REPORT AND PARAWISE COMMENTS ON BEHALF OF
RESPONDENTS NO. 5 AND 6.

Respectfully Sheweth:

BRIEF FACTS:

1. That the brief facts of the case are that in order to curtail the working under the National Accountability Ordinance, 1999 (NAO, 1999) in Sindh, on 3.7.2017 the Provincial legislators hailing from Pakistan People's Party, *inter-alia*, introduced in the Provincial Assembly of Sindh, by-passing all the prescribed procedures, the National Accountability Ordinance 1999 Sindh Repeal Bill, 2017. Despite

hostile protest from the opposition benches, the said Bill was introduced and passed without proper debate, processing and permitting any discussion. The above Bill was totally ultra-vires of the Constitution and was against the established norms and procedure, which is explained here under as well.

2. The learned Governor of Sindh was also pleased to return the Bill Back to the Provincial Assembly with observations to reconsider the same i.e. dissenting note. Despite the position that the above Bill was unconstitutional and against the spirit of Article 143 of the Constitution, the Members of the Pakistan People's Party in the Sindh Assembly re-laid the same unconstitutional bill, without any amendment, modification or change before the Sindh Provincial Assembly, again bulldozing the established norms and procedure of the Assembly and again got it passed on 26.07.2017.
3. In view of the above, it is well established that the said Bill passed by the Sindh Assembly is ultra vires of the Constitution and against the established norms and procedure, therefore, the same is liable to be struck down and be declared as improper and not maintainable piece of legislation, which shall be in the interest of justice.
4. That the subject matter is pending adjudication before this Hon'ble Court in which vide order dated 11.08.2017 the learned Court was pleased to direct the Prosecutor General Accountability to appear and

assist the learned Bench as per the order, which is reproduced as follows:

"Through this petition, petitioners have challenged vires of the enactment of National Accountability Ordinance, 1999 Sindh Repeal Bill, 2017. Let notice be issued to the respondents No.1 to 6 as well as Attorney General for Pakistan, Advocate General Sindh and Prosecutor General, NAB for 16.08.2017."

5. That on 16.08.2017 the Prosecutor General Accountability appeared before the learned Division Bench of the Sindh High Court wherein the court was pleased to direct the Prosecutor General to submit report and parawise comments and also directed to place on record complete list of the Members of Provincial Assembly, Sindh (both former and present), who are facing NAB proceedings, which includes inquiries and investigations as well as the functionaries of Government of Sindh (both former and present), alleged to have been involved in mega corruption scams.
6. That NAB is a Federal Anti Corruption Organization and primarily given role to conduct investigation and prosecution into specialized and organized crimes, white collar crimes, embezzlements and misappropriations of government/State exchequer etc.
7. That for assistance it is humbly submitted that under the provisions of National Accountability Ordinance, 1999 particularly Section 18 of

National Accountability Ordinance, 1999 deals with the jurisdiction in respect of offences:

- "18.** (a) *The Court shall not take cognizance of any offence under this Ordinance except on a reference made by [the Chairman NAB or an officer of the NAB duly authorized by him.]*
- (b) *A reference under this Ordinance shall be initiated by the National Accountability Bureau on—*
- (i) *a reference received from the appropriate government; or*
 - (ii) *receipt of a complaint; or*
 - (iii) *its own accord.*
- (c) *Where the Chairman NAB, or an officer of the NAB duly authorized by him, is of the opinion that it is, or may be, necessary and appropriate to initiate proceedings against any person, he shall refer the matter for inquiry or investigation.*
- (d) *The responsibility for inquiry into and investigation of an offence alleged to have been committed under this Ordinance shall rest on the NAB to the exclusion of any other agency or authority, unless any such agency or authority is required to do so by the Chairman NAB or by an officer of the NAB duly authorized by him".*
8. That Section 18 of NAO, 1999 is very clear that NAB has the jurisdiction throughout Pakistan in respect of inquiring, investigating and prosecuting the specialized white collar crimes. Furthermore, appropriate Government includes the Provincial Governments as per the mandate of Section 18(b)(i).

9. That the preamble of the National Accountability Ordinance, 1999 is very clear which is as under:

"WHEREAS it is expedient and necessary to provide for effective measures for the detection, investigation, prosecution and speedy disposal of cases involving corruption, corrupt practices, misuse or abuse of power or authority, misappropriation of property, taking of kickbacks, commissions and for matters connected and ancillary or incidental thereto;

AND WHEREAS there is an emergent need for the recovery of outstanding amounts from those persons who have committed default in the repayment of amounts to Banks, Financial Institutions, Governmental agencies and other agencies;

AND WHEREAS there is a grave and urgent need for the recovery of state money and other assets from those persons who have misappropriated or removed such money or assets through corruption, corrupt practices and misuse of power or authority".

10. To authorize inquiry/investigation or filing of Reference NAB needs no sanction from the government in view of the provisions of National Accountability Ordinance, 1999 as required in the cases of FIA and ACE. The law set up by the August Court in **PLD 2013 SC 594, 2014 SCMR 1567** wherein the Hon'ble Supreme Court of Pakistan held that NAB under the provisions of National Accountability Ordinance, 1999 can take action without prior sanction from Government or any Statutory Body, whereas FIR

lodged against public office holder and other senior officers under the FIA Act or other laws needs the sanction of the relevant government.

11. Furthermore, National Accountability Ordinance is distinct from the provisions of Prevention of Corruption Act, 1947 and FIA Act, 1974 qua Sindh Anti-Corruption Establishment Rules, where no mechanism of recovery is provided in law. But the provisions of National Accountability Ordinance 1999 provide categorically a mechanism to recover the amount through Voluntary Return (VR) and Plea Bargain (PB), which reflects also in the Preamble of the Statute. Furthermore, under the provisions of National Accountability Ordinance, the Chairman NAB has the power to get the cases transferred from any court to the Accountability Court under Section 16-A of National Accountability Ordinance, 1999, which has been upheld by the Hon'ble Supreme Court of Pakistan time and again recently through its judgment **2015 SCMR 588**.
12. That the National Accountability Ordinance is a special law and prevails over the other laws, general or special, whatever the case is and the Hon'ble Supreme Court held the same in **2014 SCMR 1567** and **2014 SCMR 1376**.
13. That the National Accountability Ordinance is a special law and has an advantage to execute functions under its own provisions rather under the provisions of CrPC.

14. That the jurisdiction of NAB is extended upto Federal Government, Provincial Governments, FATA and PATA, Gilgit Baltistan and Statutory Bodies created under the Federal/Provincial Legislation. In case of FIA and ACE, both the Agencies are restrained only to the extent of Public Office Holder and no mechanism of recovery is available with them.
15. That at present NAB is the focal agency with the United Nations Convention against Corruption (UNCAC) regarding anti-corruption matters.
16. That earlier vires of NAO, 1999 were challenged before the Hon'ble Supreme Court of Pakistan. The Apex Court in the case of Khan Asfandyar Wali PLD 2001 SC 607 not only interpreted Articles 141, 142 & 143 of the Constitution dealing with (1) extent of Federal and Provincial Laws; (2) subject matter of Federal and Provincial Laws, and (3) inconsistency between Federal and Provincial Laws vide para 176 of the Judgment. The Hon'ble Court also examined the question regarding invasion of the Provincial Autonomy including the question whether NAO creates a parallel judicial system in this regard the provisions of Articles 175, 202 and 203 of the Constitution vide paras 180-189 of the said Judgment and held that "the NAB Ordinance has been competently promulgated and is

neither ultra vires the Constitution nor does it invade the Provincial Autonomy in any manner.

17. That Article 143 of the Constitution is very much clear about applicability of the laws enacted by the Parliament and the Provincial Assembly, which says that "if any provision of an Act of Provincial Assembly is repugnant to any Provision of an act of Parliament, which Parliament is competent to enact, then the Act of Parliament, whether passed before or after the Act of the Provincial Assembly, shall prevail and the Act of Provincial Assembly shall, to the extent of repugnancy, be void".
18. That the vires of NAO, 1999 had already been adjudicated by the Hon'ble Supreme Court of Pakistan in Khan Asfandyar Wali Khan case as discussed above. Besides, Article 142(c) as referred in the preamble is subject to paragraph (b) of Article 142, which gives ample powers to the Parliament to enact legislation with respect to the criminal law, criminal procedure and evidence, similar to the NAO, 1999.

ON MERITS

1. No comments.
2. No comments being formal.
3. That in respect of the contents of paras 3, 4 & 5 it is humbly submitted that Articles 142 and 143 of the Constitution of the Islamic Republic of Pakistan are very clear; thus agreed:

Article 142:

Subject-matter of Federal and Provincial laws.- Subject to the Constitution—

- (a)[Majlis-e-Shoora (Parliament)] shall have exclusive power to make laws with respect to any matter in the Federal Legislative List;
- (b)Majlis-e-Shoora (Parliament) and a Provincial Assembly shall have power to make laws with respect to criminal law, criminal procedure and evidence].
- (c)Subject to paragraph (b), a Provincial Assembly shall, and Majlis-e-Shoora (Parliament) shall not, have power to make laws with respect to any matter not enumerated in the Federal Legislative List].
- (d)Majlis-e-Shoora (Parliament) shall have exclusive power to make laws with respect to all matters pertaining to such areas in the Federation as are not included in any Province.]

Article 143:

Inconsistency between Federal and Provincial law.- If any provision of an Act of a Provincial Assembly is repugnant to any provision of an Act of Majlis-e-Shoora (Parliament) which Majlis-e-Shoora (Parliament) is competent to enact, then the Act of Majlis-e-Shoora (Parliament), whether passed before or after the Act of the Provincial Assembly, shall prevail and the Act of the Provincial Assembly shall, to the extent of the repugnancy, be void.]

4. The vires of NAO, 1999 had already been looked in by the Hon'ble Supreme Court of Pakistan in view of the provisions of the Constitution in Khan Asfandyar Wali case. Furthermore, recently after the enactment of Ehtesab Commission in Khyber

Pakhtunkhwa(KPK), the same matter was adjudicated before the learned Peshawar High Court (**PLD 2016 Peshawar 114**) wherein the Full Bench of learned Peshawar High Court observed in para 24 (pages 146, 147 & 148) as under:

"Provisions of National Accountability Ordinance, 1999 and that of Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 were at par with each other, and in case of assuming parallel jurisdiction over a matter, the provision of S.35 of Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 would be resorted. Provisions of Ss.35 and 56 of Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 had left enough room for the Federal law, as the same provided the functionaries under the Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 would not initiate proceedings in a matter for which the federal agency had already taken cognizance, unless said federal agency was convinced that the matter pertained to their jurisdiction and that in case of any conflict between the Khyber Pakhtunkhwa Ehtesab Commission Act, 2014 and Federal Law, the provisions of the Federal Law would prevail. Laws in question could very well be treated to be complementary to each other. Only keeping the two laws in juxtaposition was not safe idea to determine the question of 'occupied field', because that had also to be seen whether the two law could proceed side by side without blocking each other."

5. Furthermore, in **2014 SCMR 535** (and other SC cases), the Hon'ble Supreme Court of Pakistan has categorically observed in respect of application of Article 143 qua the supremacy of Federal legislation over the Provincial legislation.

6. That in respect of the contents of paras 6, 7, 8 & 9 of the subject Constitution Petition, it is respectfully submitted that the same is a matter of record and true and factual position in this regard. During the course of proceedings on 16.08.2017 the learned Bench was pleased to direct NAB to place on record complete list of the Members of Provincial Assembly, Sindh (both former and present), who are facing NAB proceedings, which includes inquiries and investigations as well as the functionaries of Government of Sindh (both former and present), alleged to have been involved in mega corruption scams. In addition to above, the list of Federal Government Functionaries, serving with the Government of Sindh, facing proceedings of NAB is also attached. The lists are annexed as Flags "A", "B" & "C" for the perusal of the court.
7. That in respect of paras 10, 11 & 12 of the subject Constitution Petition, it is humbly submitted that the same are matter of facts and need no comments of the answering respondents.
8. That para 13 is formal, hence needs no comments.


GROUND:

1. That grounds 'A', 'B', 'C', 'D' & 'E' are appropriate and are agreed.
2. That as regards ground 'F', it is an established norm of law in respect of overriding effect with provincial legislation that cannot override the provisions of the Constitution. Furthermore, it has been specifically held by the Hon'ble Supreme Court of Pakistan in Khan Asfandyar Wali case that the National Accountability Ordinance, 1999 is a valid

piece of legislation and shall apply to all persons in Pakistan. It is also held by the Apex Court in Asfandyar Wali's case (para-181) that NAB Ordinance have been competently promulgated and is neither ultra vires the Constitution nor does it invade the Provincial Autonomy in any manner.

3. That ground 'G' is true and in accordance with the facts at grounds.
4. That ground 'H' is formal.


