Counsel undertakes to file a copy of said Apex Court's order and says that after the said order, the letter dated 26.01.2017 has again come into the field and in case the impugned letter (dated 26.01.2017) is not suspended, the petitioner would proceed to shut the transmission of their TV channel. Let notices be issued to the respondents as well as D.A.G. for 22.02.2017. In the meanwhile the operation of letter dated 26.01.2017 is suspended.
