At the outset, Mr. Amer Raza Naqvi, learned counsel for Respondents No.10 and 11 frankly concedes that it is purely a prerogative of the trial Court to add or to delete any section from the challan. We would, therefor, with the consent of all present, order that the trial Court shall examine the supplementary report placed before it and decide the question on merits and strictly in accordance with law through a speaking order. Through the above, the clauses (a), (b) and (c) of the prayer clause, set out in the petition, stand satisfied. Regarding the remaining reliefs

sought, the counsel for the Petitioner requests for adjournment, so that appropriate orders may be passed thereon after hearing all the counsels and perusing the relevant material.

Mr. Ashikue Raza, learned DAG alongwith Ms. Rukhsana Sayal, Standing Counsel, submits that since clauses (a), (b) and (c) of the prayer clause, which perhaps pertain to the Federal Government also, have already been dealt with through the present order, the Federation of Pakistan may be deleted from the array of Respondents. By consent, the Federation of Pakistan is deleted from the array of Respondents. Such be effected through red ink in the title of the petition.
