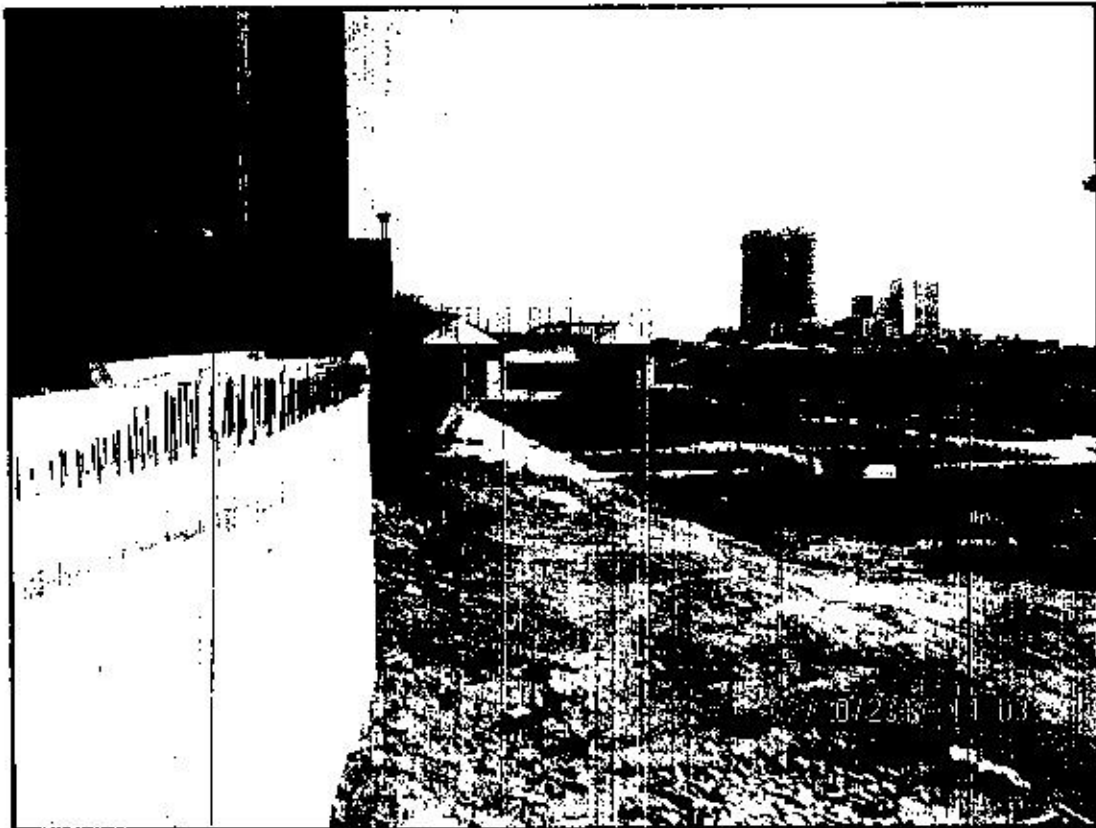

Following observations / points are given below regarding Property

AT M/S BEHRIA ICON / BIN QASIM PARK CLIFTON KARACHI.

We have visited on 2nd October 2017 on the presence of high court's staff. Plaintiff and petitioner.

1. During visit I found main hole nearby to behria Icon's which is made for Madina masjid and behria outside surrounding / underpass-I storm water drain. That main hole later on connected to main line constructed by government authority.]
2. Under pass #2 is situated near main Clifton road that underpass storm water drain line laid in slope to main sewerage line which is parallel to fish aquarium. that main connection with underpass through 36" dia.
3. Both main holes (4'x4'x10') found at Bin Qasim Park with 36" dia pipe line.]
4. Main holes are serves for underpass storm water drain laid in the center of the bin Qasim park.



5. For the connection of Behria Icon.
 - a. There is no connection found during site visited with above mentioned main hole line.
 - b. Behria icon Clifton have own sewerage line connection which is constructed on the left side road of the icon near Abdullah shah ghazi tomb.
 - c. Main sewerage line lay in slope towards Abdullah shah ghazi tomb.
 - d. Upper level sewerage line is also in slope towards Abdullah shah ghazi tomb.

3.0 Remarks

THIS IS TO CERTIFY that we have carried out a detailed inspection of the subject property after verification at site, offered to us on date of attendance, at the mentioned address, to the best of our ability and judgment, based on our experience of such type of property.

The inspection report consists of 06 pages and is valid for three years from the date of issue.

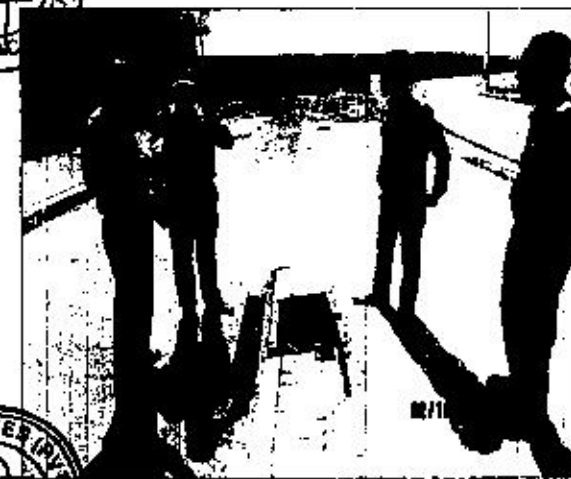
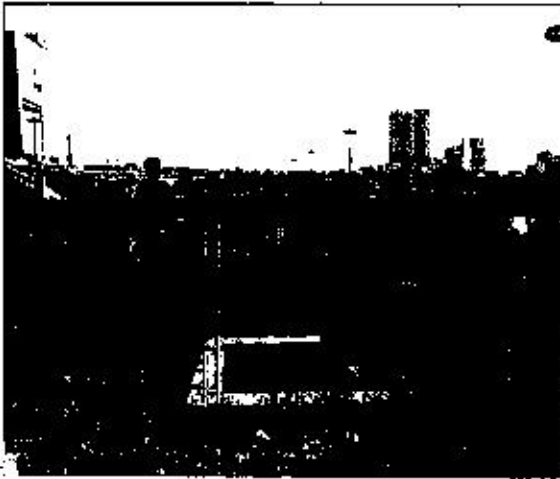
