

Parks, as well as a licensed architect, who will be appointed by the Nazir, representative from the respondents. Nazir or his representative shall take photographs and will furnish his report within one month's time. Fee of the Nazir tentatively is fixed at Rs.30,000/- payable by the petitioner in advance. Fee of the architect would also be paid by the petitioner, as per the bill furnished by them.
