PROGRESS REPORT OF MS. PERVEEN REHMAN MURDER CASE.**FIR No.104/2013 u/s 302/34 PPC r/w 7 ATA 1997****PS PEERABAD DISTRICT WEST KARACHI**

It is submitted that in compliance of the orders of the Honourable Supreme Court of Pakistan during the last hearing of the Constitution Petition on 10.10.2017, the progress report is as under:

The undersigned constituted a special investigating team under the supervision of SP Investigation-I West Zone, Karachi vide this office order No. DIGP/ W-Z/Legal Br/ 58628-35/2017 dated 11-10-2017 to ensure the arrest of the remaining absconding accused at the earliest. The SP Investigation-I West Zone has reported that the dedicated efforts for the arrest of absconding accused persons were made with enthusiasm resultantly Muhammad Amjad Hussain Khan s/o Muhammad Jameel Khan was arrested. Report of SP Investigation- I **annexed "A"**.

Detail of investigation is as under:

1. Arrest of accused Amjad Afridi

During the search of accused persons, absconding in subject case, Inspector Muhammad Urs Rajar, SIO Manghopir Police Station, succeeded in arrest of accused Muhammad Amjad Hussain Khan @ Amjad Afridi s/o Jameel Ahmed Khan on 24.10.2017, while in possession of an illicit pistol and a hand grenade. Vide such fact Inspector Muhammad Urs Rajar lodged FIR Nos. 310/2017 and 311/2017 u/s 4/5 Explosives Act r/w 7 ATA and 23-i(a) SAA, respectively, at Manghopir Police Station. On information, Inspector Muhammad Fareeduddin, I/O of the case re-arrested the accused in case FIR No. 104/2013 of Peerbad Police Station.

2. Interrogation by I/O and Joint Interrogation Team:

I/O of the case, Inspector Muhammad Fareeduddin interrogated the accused who admitted his guilt. On the request SP Investigation-I, Secretary to Government of Sindh, Home Department constituted a Joint Interrogation Team, vide order No. SO(LE-I)HD/8-2/2017, Karachi, dated: 27th October 2017 for interrogation of accused Muhammad Amjad Hussain Khan.

The Joint Interrogation Team convened a session at the office of SP Investigation-I on 30th October 2017 at 1200 Noon. The team thoroughly interrogated the accused, who confessed his guilt in the murder of Miss Parveen Rehman and disclosed about his assistance providing to the accused Rahim Sawati and others for the commission of crime. The Joint Interrogation Team further declared the above named accused as **Black**. Report of JIT annexed "B".

3. Interrogation of Police Officers

In view of the application of petitioners, given to Inspector General of Police Sindh and observation of Honorable Supreme Court of Pakistan, Inspector Raja Ulfat Hussain (First I/O of the case) and SI Ashfaq Baloch (SHO Manghopir, when accused Qari Bilal was killed in encounter) were brought under investigation entire a day and thoroughly interrogated in Parveen Rehman Murder Case by Inspector Muhammad Fareeduddin, I/O of the case.

In his statement, Inspector Raja Ulfat Hussain stated that during initial investigation of the case, he declined any kind of benefit to any accused as a result of his investigation.

In his statement, Sub-Inspector Ashfaq Hussain Baloch of PHQ West Zone Karachi stated that on 14-03-2013 he was posted as SHO Manghopir Police Station, he ruled out providing any kind of support to any accused as a result of the encounter in which accused Qari Bilal was killed. Security of Orangi Pilot Project Office

PROGRESS UP TO DATE IN THIS CASE IS AS UNDER**a. Arrest of prime accused Rahim Sawati:**

During hectic efforts made by above quoted team, accused Rahim Sawati was earlier arrested after an encounter at Manghopir Police Station, while in possession of illicit weapon and explosive. Vide this fact cases FIR Nos. 114, 115 & 116/2016 registered at Manghopir u/s 353/324/34 PPC r/w 7 ATA, 23-i(a) SAA and 4/5 Explosive Act r/w 7 ATA, respectively. The accused was rearrested in the present case.

❖ Final Charge Sheet:

In view of the confession of accused Rahim Sawati before SSP Investigation-I West Zone and opinion of Joint Investigation Team, I/O found some accused persons, guilty of the offence, while some of them found not involved. The detailed break up of accused persons, with respect to their status in charge sheet u/s 302/201/202/109/34 PPC r/w 7/11(N)/11V(ii) ATA 1997 r/w 512 Cr.P.C., is appended below:

There were (26) witnesses in the case, out of which 13 have been examined till yet. Remaining witnesses will be produced before trial court on the date of hearings to complete the trial at earliest.

4. Future course of action

Arrest of Ayaz Ali @ Ayaz Sawati s/o Muhammad Shirin

1. Registration details of accused were obtained from NADRA which shows his CNIC Number as 42401-1815031-5 and address as House No. 236 Sector 5/A/L Qasba More Near Akbar Masjid District West Karachi
2. Raids were conducted for the arrest of fugitive but not found residing at the address. Information received that he is out of country in Muscat.
3. Publication of proclamation U/S 87 & 88 Cr.PC r/w 19(10) of ATA 1997 proceeding have been initiated against the above named absconding accused by the Trial Court annexed "E".
4. Applications for issuance of Red Warrant and placing the name of fugitive on Exit Control List are in process for the apprehension of the accused.
5. All available sources and resources are being utilized for the arrest of fugitive and hopefully he will be arrested soon.

The principal accused persons involved in the case including Mohammad Rahim Sawati, Muhammad Amjad Hussain Khan and others namely Ahmed Khan @ Papoo Kashmiri s/o Abdul Baqi & Muhammad Imran s/o Muhammad Rahim have been arrested and the case is pending trial in ATC-VII Karachi. Hopefully the positive result will be surfaced in near-future.

It is submitted that the progress made since last date of hearing the
following progress has been made by this unit:

1. Arrest of accused Amjad Afridi

During search of accused persons, absconding in subject case, Inspector Muhammad Urs Rajar, SIO Manghopir Police Station, succeeded in arrest of accused Muhammad Amjad Hussain Khan @ Amjad Afridi s/o Jameel Ahmed Khan, while in possession of an illicit pistol and a hand grenade. Vide such fact Inspector Muhammad Urs Rajar lodged FIR Nos. 310 and 311/2017 u/s 4/5 Explosives Act r/w 7 ATA and 23-i(a) SAA, respectively, at Manghopir Police Station. On information, Inspector Muhammad Fareeduddin, I/O of the case re-arrested the accused in case FIR No. 104/2013 of Peerbad Police Station.

2. Interrogation by I/O and Joint Interrogation Team:

I/O of the case, Inspector Muhammad Fareeduddin preliminarily interrogated the accused who admitted his guilt. On request of the undersigned, The Secretary to Government of Sindh, Home Department, constituted a Joint Interrogation Team, vide order No. SO(LE-I)HD/8-2/2017, Karachi, Dated: 27th October 2017 for interrogation of accused Muhammad Amjad Hussain Khan.

The Joint Interrogation Team convened a session at office of the undersigned on 30th October 2017 at 1200 Noon. The team thoroughly interrogated the accused, who during his debriefing stated that:

"Mrs. Parveen Rehman was director in Orangi Pilot Project, whose office is located at Qasba More Sector 5-A Area, this office is in front of his and Raheem Swati's house. Former president of constituency PS-96, Ayaz Swati had a dialogue with Raheem Swati that they have to obtain space from Orangi Town Pilot Project for construction of a Karate Centre for youth of the area, but in spite of their repeated requests Mrs. Parveen Rehman refused to provide land in their compound and termed their requests are ANP's Qabza Mafia which is insult of ANP. On such, in January 2013, a meeting convened at Rahim Sawati's house in which he, Ayaz Swati and Ahmed Ali @ Papoo participated. They have planned assassination of Mrs. Parveen Rehman as revenge. Rahim Sawati, using Ayaz's phone, called local commander of Taliban namely Moosa and Mehfoozullah @ Bhaloo, who gave them a nod against payment of cash to them and all three of us assured them payment after completion of task. They seek help of Ahmed Ali @ Papoo Kashmiri for accomplishment of the task. On such demand, Ayaz and Rahim directed Papoo Kashmiri to be in contact of Moosa and Bhaloo. Thereafter, he, Rahim and Ayaz observed routine of arrival / departure of Mrs. Parveen Rehman and intimidated Moosa and Bhaloo. On 13-03-2013, Moosa, Bhaloo and Papoo Kashmiri targeted Mrs. Parveen Rehman in front of Pakhtoon Market at 0730 evening. At that time he and Ayaz were present at their back for support. Same evening Moosa intimidated Raheem Sawati that they have completed their target, now you have to pay. He and Ayaz went to Rahim's house and told him details of job done by Papoo Kashmiri, Moosa and Bhaloo. During initial investigation by Police, he and other people of vicinity recorded their statements to misguide the police. Raheem Sawati told him that due to non payment, Moosa called Rahim after couple of days to pay four million rupees to him in the path made by Allah but he could not manage. Therefore Moosa and his accomplice attacked on Rahim's house with grenades, due to which he frightened and escaped to his native place. He visited his house with different intervals of time concealing his movement.

3. Interrogation of Police Officers

In view of the application of petitioners, given to Inspector General of Police Sindh and observation of Honorable Supreme Court of Pakistan, Inspector Raja Ulfat Hussain (First I/O of the case) and SI Ashfaq Baloch (SHO Manghopir, when accused Qari Bilal killed in encounter) were called and thoroughly interrogated by Inspector Muhammad Fareeduddin, I/O of the case.

In his statement, Inspector Raja Ulfat Hussain stated that during initial investigation of the case he seized 2x empties 9mm from crime scene and completed other formalities. He sent empties for cross match with weapon recovered from possession of killed accused Qari Bilal, which were found similar. As the opinion of

expert is admissible evidence as per Qanoon-e-Shahadat; thus, he included name of killed accused in the case. However, he continued the efforts for tracing the real culprits. In case of no likelihood of detection of case in near-future he submitted report u/s 173 Cr.P.C. to court as Untraced on 05-11-2013. When hearings of Constitution Petition NO. 50/2013 started before Honorable Supreme Court of Pakistan, Court ordered an inquiry to DJ West Karachi. He assisted District and Sessions Judge West Karachi. On inquiry report of DJ West Karachi, the august court directed constitution of JIT. During first session of JIT section 7 ATA inserted in the case and investigation was earlier handed over to Inspector Nafees-ur-Rehman and later to Inspector Muhammad Fareeduddin. He declined any kind of benefit to any accused as a result of his investigation.

In his statement, Sub-Inspector Ashfaq Hussain Baloch of PHQ West Zone Karachi stated that on 14-03-2013 he was posted as SHO Manghopir Police Station. While on patrolling he received information regarding present of 3/4 armed suspects in a white colored Toyota Platz car. In Sultanabad he found the car and engaged in encounter with accused persons. As a result of encounter, he succeeded in arrest of one accused in injured condition while remaining made their escape good from crime scene. The injured accused who disclosed his name as Qari Bilal expired on the way to hospital. The 3x empties 9mm seized from crime scene and later lodged FIR Nos. 86/2013 u/s 353/324/186/34 PPC 7 ATA and 87/2013 u/s 23-i(a) SAA against accused persons. Moreover, the car found snatched in crime No. 85/2013 u/s 392/34 PPC of Manghopir Police Station. He ruled out providing any kind of support to any accused as a result of his encounter.


4. Future course of action

CRIMINAL HISTORY

1. MURDER OF Mrs. PARVEEN REHMAN

- 1) Qasba colony and sector A, KDA Block are almost attached, therefore, we have rivalry with workers of MQM. The exchange of firing is a routine these days. For firing we obtained arms ammunition from unit 53 of ANP whose In-charge was Mian Gul Ahmed Ali @ Papo Kashmiri was leading activist who used to kill MQM workers. In such firing 1) Naveed @ Salaar, 2) Imran @ Punjabi, 3) Lateef & 4) Ayaz were his accomplices.
- 2) Raheem sawati is his neighbor and was Secretary Information in ANP. His son Imran Swati was also a worker of ANP, who used to make firing to continue hold in the vicinity, just like him. In 2006 Ayaz Swati remained In-charge in ward 222 for two months, later he was office bearer in UC-9 Unit purchased weapons from collected contribution, which was collected from business community of the area.

- 3) Mrs. Parveen Rehman was director in Orangi Pilot Project, whose office is located in Qasba More Sector 5-A Area, this office is in front of his and Raheem Swati's house. Former president of constituency PS-96, Ayaz Swati had a dialogue with Raheem Swati that they have to obtain space from Orangi Town Pilot Project for construction of a Karate Centre for youth of the area, but in spite of their repeated requests Mrs. Parveen Rehman refused to provide land in their compound and termed their requests are ANP's Qabza Mafia which is insult of ANP. - 4) On 24-10-2017, he came to Karachi and moving in the area, but Manghopir Police arrested him, while in possession of illicit weapon and hand grenade, which was kept by him for self defense.

FINDINGS:

Suspect found actively involved in target killings and other criminal activities, therefore he placed in category of Black.

RECOMMENDATIONS:

On basis of above findings it is recommended the suspect may be arrested in the crimes disclosed by him by respective Police officers.


