SUBJECT: HUMAN RIGHTS CASE No 1949 - K of 2018
IN THE MATTER OF MURDER OF NAQEEB ULLAH MAHSOOD IN ALLEGED FAKE POLICE
ENCOUNTER AT KARACH.

Take notice that the above noted case came up for hearing
before the Court on 13.03.2018 when the following order was passed;

"Vide our earlier order dated 16.02.2018, reports have been submitted by the ISI and the MI, stating therein that full assistance is being provided to the Sindh Police and also efforts are being made through home resources as well as by technical means to find out the hideout of Rao Anwar, SSP Malir (since suspended) and other accused involved in the matter but no success so far has been achieved. At this point, we perused a letter dated 09.03.2018 appearing at Page 22 of the report so submitted, as per which it seems that the CCTV footages of the Karachi Airport, wherefrom Rao Anwar departed from Karachi to Islamabad, and the Islamabad Airport, from where he intended to leave abroad, are necessary to be looked into and viewed. We asked the Inspector General of Police, Sindh (I.G.P. Sindh) whether these footages are available with him, he replied in affirmative. Let those footages be played in-camera in our Chambers at Branch Registry of this Court at Karachi on 16.03.2018 (Friday). The Director General of the Airport Security Forces be also present on the said date. Re-list accordingly."

Take further notice that the above cited matter is accordingly fixed for next hearing before in Chambers on 16.03.2018 (Friday) at 9:00 a.m. in the Court House, at Branch Registry, Karachi. You are, therefore, required to ensure compliance of the above reproduced Court order in letter and spirit and also to appear in the Court House, at Branch Registry, Karachi on the date and time fixed without fail.
