

### Respected Sir,

Respectfully stated that the facts of investigation in the above subject case are that:

On 23.01.2018 the FIR has been registered on the written application of complainant of the case Muhammad Khan son of Mama which is reproduced as under:-

To the SHO Police Station Sachal Karachi.

### Respected sir,

It is submitted that I Muhammad Khan son of Mama Asal resident of South Waziristan presently residing at Karachi. My son Naqeebullah Masood who came at Karachi for work/labour He was 24 years old and on 03.01.2018 at about 0300 O'Clock in noon 8/9 officials of SSP Malir Rao Anwar dressed in civil clothes picked him from Gul Sher Agha Hotal Chappal garden Abul Hassan Isphani road Karachi alongwith Hazarat Ali son of Shakir Qaseed and Muhammad Qasim son of Daad, who were left on 06.01.2018 at about 10.00 p.m. in night at Super highway Karachi, while, my son was still kept in confinement by Rao Anwar and they switched off the mobile phone of my son. My friends and relatives made search for him. On 17.01.2018 through TV and Newspaper news was published that my son has been killed by Rao Anwar and his associates in Fake Police Encounter on which IG Sindh has constituted an inquiry consisting of Higher officers of Police, who in their findings have found the involvement of the Rao Anwar and his subordinates. Besides the high-ups Sherdab Khan son of Sharbat Khan and Humaiyun son of Muhammad and many more are the witness of the incident. Therefore my claim is against SSP Rao Anwar and his 8/9 subordinates (whose names need to be discovered) who abducted my son Naqeebullah and kept him in illegal detention and killing him in fake police encounter. Case is registered. This incident has spread fear and terror amongst the people, case be lodged and action be taken. Therefore on the written application of the complainant of the case FIR had been registered by SHO inspector Shakir Ali and the investigation of the case has been entrusted to me SSP Investigation by the orders of the high-ups.

During investigation, as per the pointation of the eye witnesses namely Muhammad Qasim son of Dawood Khan and Hazrat Ali son of Shakir visited the place of incident and after examination Memo of examination of place of incident and memo of pointation of Police Chowki Abbasi town was prepared separately. Memo of map was prepared, photographs were taken and recorded statements under section 161 Cr.P.C. of the complainant and other witnesses. During investigation obtained particulars of the 16 nominated accused persons i.e. amongst the police party. For the purpose of arrest



of the accused persons letters were issued for approval of police party. Letters were issued to the Tapedar for preparation of the Scaled map of the place of incident. During the course of investigation Medical examination of the abductees namely Muhammad Qasim son of Dawood Khan and Hazrat Ali son of Shakir was conducted. During investigation on 26.01.2018 formally arrested the nominated accused persons namely (1) ASI Allayar Kaka son of Juma Khan (2) HC Khizar Hayata son of Noor Muhammad 19451 (3) HC Muhamamd Iqbal son of Ahmed Yar 14694 (4) PC Arshad Ali Son of Mazhar Ali 5648 (5) SIP Muhammad Yaseen son of Ahmed Yar (6) ASI Supurd Hussain son of Ghulam Hussain. After the approval of the Home Department the high-ups have constituted teams which conducted raid in different cities of Pakistan for the arrest of the accused persons and still are raiding.

On 26.01.2018 IGP Sindh with reference to Order No. 3538-49/AIGP/OPS/III/2018 dated 26.01.2018, constituted a team for investigation under the supervision of Addl IGP Sindh PSP Mr. Aftab Ahmed Pathan. Copy of the Order is enclosed. In connection with the investigation letters has been received on various occasions from the high-ups, which are enclosed. During investigation obtained the Mobile Phone Numbers record of the accused persons and upon inspection it is revealed that the involved accused persons were present at the place of incident at the time of extrajudicial killing of the victims. (Detail record is enclosed). During investigation on 27.01.2018 the arrested accused persons were produced before the Administrative Judge ATC at High Court of Sindh and obtained police custody remand till 31.01.2018. On 27.01.2018 the Supreme Court of Pakistan vide HRC No. 1949-K-2018 took Suo Moto notice of the incident. (Copy is enclosed). Letters have been sent to the other agencies in connection with the search of the accused persons. During investigation the arrested accused persons were interrogated very proficiently one by one and upon their pointation raid were conducted at different places for the arrest of the non arrested accused persons. During investigation as per the pointation of the arrested 6 accused persons memo of pointation of place of incident was prepared.

Prior to this on 13.01.2018, case was registered under FIR No. 17/2018 under Section 353/324/34 PPC, 3/4 of Exp Sub Act R/W 7ATA and the accused persons of that FIR are the victims of the instant FIR against who under Section 24 of Arms Act cases have been registered by the complainant SHO/SIP Amanullah Marwat posted at police Station Shah Lateef Town Malir Karachi. (1) FIR No. 18/18 under Section 24 of Sindh Arms Act against accused Muhammad Ishaq son of Raheem Bux for recovery of 1x TT pistol 2 bullets loaded and a chamber fractioned. (2) FIR No. 19/18 under Section 24 of Sindh Arms Act against accused Muhammad Sabir son of Muhammad Bux for recovery of 1x TT pistol 2 bullets loaded and a chamber fractioned.(3) FIR No. 20/18 under Section 24 of Sindh Arms Act against accused Nazar jan son of Atam Khan for recovery of 1x Rifle 222 magazine carrying 3 rounds and on chamber loaded. (4) FIR No. 21/18 under Section 24 of Sindh Arms Act against accused Muhammad Naseem Ullah @ Naqeebullah son of Muhammad Khan for recovery of 1x TT pistol 2 bullets and chamber fractioned. After the registration of the cases as mentioned above



the investigation was entrusted to Inspector Nasrullah posted at Police Station Shah Lateef Town Malir Karachi. During investigation Inspector Nasrullah on the pointation of the complainant of the case SHO /SIP Amanullah Marwat on 13.01.2018 examined the place of incident and took photographs and map was prepared of the place of incident. Witnesses posted at Shah Lateef town Malir Karachi (1) SHO/SIP Amanullah Marwat (2) HC Sadaqat Ali Shah 15448 (3) PC Raja Shamim 27970 (4) HC Mohsin Abbas 17701, (5) ASI Gada Hussain statements under Section 161 Cr.P.C. has been recorded. On the information of the ASI Saleem Ahmed Duty officer SHO with reference to Report No. 28 @ 1520 reached at the place of occurrence alongwith HC Mumtaaz Ali 15730 and PC Zafar Iqbal 11634 and took the dead bodies of the deceased persons namely (1) Muhamamd Ishaq son of Karim Bux (2) name and address not known (3) Nazar Jan son of Atam Jan (4) Name and Address not known were sent through Chippa and Edhi Ambulance to the Jinnah Hospital. At Jinnah hospital proceedings under Section 174 Cr.P.C. of all the four bodies was conducted in presence of witnesses namely HC Gulzar Ahmed 19300, HC Mumtaaz Ali 15730 and the copies of the proceedings were handed over to the MLO Dr. Abdul Ghaffar. MLO did the postmortem with reference to MP No. 22/2018 to 25/2015 and declared the reason of the deceased persons as death from the arms fires and also took photographs of the dead bodies. Due to non availability of the relatives/heirs the dead bodies of the victims were kept in the mortuary at Chippa Sard Khana. On return the proceedings were entered vide report No. 48 at 0010 hours dated 14.01.2018 and the proceedings documents alongwith four bundle particles and samples duly sealed were handed over to IO Inspector Nasrullah. Who recorded statements under section 161 Cr.P.C. of the ASI Saleem Ahmed and witnesses HC Gulzar Ahmed and HC Mumtaaz Ali and Guard Commander HC Muhammad Ali. The exploded hand grenade that was recovered from place of incident, was sealed by SI Jan Muhammad Mangi of BDU and alongwith Clearance Certificate was handed over to Duty officer SI Qurban Ali Totani, Statement under Section 161 Cr.P.C. of the Duty officer was recorded. During investigation, the encounter person / victim no. 4 who was killed on 17.01.2018, who was identified as Naseemullah @ Nageeullah son of Muhmmad Khan caste Mehsood, by his uncle Mamo Muhamamd Hussain son of Khizan Gul resident of Hub Chowki Balochistan and permanent resident of Bahdurkhel Taluka Makyan district South Waziristan Agency Mobile No. 0345-2786950 who came alongwith Saif ur Rehman son of Mehar Dil Khan (cousin of the deceased) came before the Ist IO Inspector Nasrullah, who were given letter for Chippa Cold House for the funeral of the dead body, statement of the above said tow persons was recorded and transitory certificate for carrying the dead body to the native place was issued. On the orders of the IG the Inquiry committee consisting of Addl IGP CTD Sindh Karachi (PS) posted at CTD (Chairman) (2) DIGP Sultan Ali Khawaja (PSP) East Zone Karachi (Member) (3) DIGP Azad Khan (PSP) South Zone Karachi (Member) submitted the detail report, according to which the so called police encounter was declared as fake and the cases lodged against the victims were terms as false cases. Copy of the report is enclosed.



Meanwhile, the investigation of FIR No. 17/2018 and other connected cases was transferred to me Investigating officer with reference to Order No. DIGP/EAST/RDR/261/2018 dated 21.01.2018 and on the same day DIG East Zone in assistance of the investigation vide Order No. DIGP East RDR-262/2018 constituted an investigation team consisting of SSP Investigation I East Zone, SSP investigation 3rd East Zone and SSP CTD operation Sindh. The complainant of the above FIRs and witnesses, who by the time had gone underground. Notices were pasted at the Houses of SSP Rao Anwar, SIP Shoaib Shaikh, SIP Amanullah Marwat and others. The motorcycle which was shown to be recovered from the deceased persons i.e. Motorcycle No KHN-5858 which was kept at Police Station Mobile Town on 02.12.2016 under seizure, the copy of the seizure registered was obtained on 22.01.2018 alongwith 5x official SMG alongwith Magazine and bullets as per memo alongwith Kot Register was taken into police custody and was sealed. After which the same were submitted for FSL examination. On 23.01.2018 Hafiz Abdul Wahid son of Khair Muhammad resident of basti Long Wali Muhamamd Lang Gardan Hyderpur Taluka Ahmedpur Shirkia mobile No. 0300-4093763, who identified the victim no. 2 as real nephew was given letter for the Chippa Cold House for obtaining dead body and also transitory certificate was given so that the dead body could be taken to the native place for funeral ceremonies. His statement was recorded. On receipt of the postmortem report the bundles of particles and blood polluted soil were sent for chemical examination. The FSL reports and chemical report of the case property as detailed above and BDU Inspection report were received which are enclosed. In FIR No. 17/18 under Section 353/324/34 PPC R/W 7 ATA the forensic report of the place of incident was received with reference to AIG/FD/OR/F-A/442/A Dated 22.01.2018. After the examination the FSL authorities have stated in their report which is as under:

### The Examination of the crime scene has revealed that:

- (1) Boundary wall: Impacts on the outside of boundary wall, no any impact found on the inner side of boundary wall. One entrance on the frame of main door.
- (2) Room No. 1 (Left Side): Impacts on inner side of back and right side wall.
- (3) Room No. 2 (Middle): Impacts on inner side of back and right side wall holes of projectile found on the window of back side wall. (Fired from inner side) and holes on the door (Fired from outside).
- (4) Room No. 3. (Right Side): No any evidence of projectile trajectory found in the room.
- (5) Direction of Fire: Direction of fire was from front side of house towards back side of the house.

The Recovered 26x fired bullets of SMG which were recovered from the outside of the house, these were found from same place by the inspection team during the examination, and these were



examined/matched with the police Party official SMGs and the report was received vide reference No. AIG/FD/OR/FA 544-A Dated 26.01.2018. The examination report was received under (Dissimilar), which establishes that on the day of incident the complainant of the case SHO has not taken the fired bullet empties fired from the official SMG and thereafter the fired bullet cases were kept there intentionally and as such has attempted to hide the real facts, to temper with the evidence and to hinder in obtaining of justice. The cases lodged against the encountered persons in the above case has been disposed off in Class B after the investigation and approval of the highups.

In such circumstancesFIR No. 142/2018 under Section 26 of Sindh arms Act, R/W 3 / 4 of Exp Act R/W 7ATA was lodged at police station Shah Lateef Town Karachi against Case may be lodged against accused persons namely (1) Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan (2) Ex SIP Muhammad Anar son of Umer Hayat Tarar (3) Ex HC Faisal Mehmood son of Muhammad Naib (4) Ex PC Shamim Mukhtiyar son of Raja Mukhtiyar Hussain (5) Ex SIP Amanullah Marwat son of Saeedullah Khan (6) Ex ASI Gada Husasin son of Faiz Muhammad (7) Ex HC Sadaqat Ali Shah son of Ghulam Hussain Hamdani (8) Ex HC Mohsin Abbas son of Noor Zaman (9) Ex PC Rana Riaz Ahmed son of Fayyaz Ahmed (10) Ex SIP Shaikh Shoaib @ Shoaib Shootar son of Shaikh Asghar Ali (11) Ex ASI Khair Muhamamd son of Jamal Din (12) Ex SDPO Malir City Qamar Ahmed Shaikh.

On 26.01.2018 in the above case the eye witnesses and abductees namely Hazrat Ali and Muhammad Qasim recorded their statements under Section 164 Cr.P.C. before the JM IV Malir Judge Mir Sagar Khan Abro and on 31.01.2018 the identification parade of the arrested accused persons namely ASI Allahyar Kaka son of Juma Khan (2) HC Muhamamd Iqbal son of Ahmed Yaar 14694 (3) PCPC Arshad Ali son of Mazhar Ali 5648 was carried out through the eyewitnesses and abductees namely Qasim son of Dawood and Hazrat Ali son of Shakir before the JM IV Malir Karachi. In the identification parade the witnesses identified all the three accused persons, the copy of the identification parade is enclosed. CRO, Photo Finger was conducted of the accused persons. On 01.02.2018 further police remand of the arrested accused persons was obtained from the competent court till 06.02.2018. during investigation the Raiding parties for the arrest of the accused persons supplied their reports which are enclosed.

The important points of the Statement under Section 164 Cr.P.C. of the eye witnesses and abductees are as under:

(1) On the 3<sup>rd</sup> of 4<sup>th</sup> day on Thursday Month January year 2018 at about 0245 o'clock I alongwith my friend Qasim had gone to Al-Asif for clothes. There I got a message from Naqeeb on messanger that I am missing you come and meet me and I am at Sardar Hotel and he called me at Sher Agha hotel at Ali Town Isphani road. Meanwhile, I received phone call from Naqeeb that he has reached at Sher Agha Hotel. I and Qasim reached at 0300 o'clock and met Naqeeb



and parked the motorcycle. As soon as we seated in the hotel the waiter came who was given order by the Naqeeb to bring three cup of tea alongwith 4/5 pieces of cake and before the waiter could bring the order 8 to 9 persons in civil dresses came and took all three of us to the Police Mobile Van standing outside the hotel amongst these people some were wearing pant shirts while other were dressed in Shalwar Kameez, some of them had pistols in their hands and the others were holding Kalashinkov, they took us from there to Sachal Police Chowki forcibly on the gun point. They kept all three of us there whereafter they separated us from Naqeeb and took us to the other room. In that room 3 to 4 persons came and starting asking us that what meeting was going on? On which we replied that Naqeeb is a friend and we just get together there. After about 40/45 Minutes two persons came into the room and one of them opened the gate and the other stripped our eyes and also tied our hands on the back.

- (2) When we asked them that where they were taking us they said that you are being taken to Rao Anwar from where you will go to Jannat, they seated us in a car and as soon as we get in the car I felt cold breeze on my head and also heard the sound of door lock. About 40/45 minutes travelling we were took out at some unknown place and about 10 to 15 steps they asked us to sit where they untie our hands and put chains in our feet and put locks on the chain they told us that when the door will knock, you should understand that Rao Anwar has come and tied the stripes on your eyes tightly. Before the Rao Anwar came when we opened our eyes we saw that we are confined in a room and Naqee is also with us when we asked him he informed that he was also in the same car in which we were brought there.
- (3) Naqeeb has informed that police has beaten him badly and were demanding Rs. 10 Lac/from him. Naqeeb informed that I am a poor person and I not even able to arrange 50,000/-. After 2/3 hours the gate was opened and the voice of the person talking to us was familiar, he asked our names all three of us disclosed our names, then he asked where do you live we replied at "Manghopir" and then "from where do you belong" he again asked, we replied this question also. Then ye again asked "are you Mehsuds" we replied in affirmative and then he went away and we heard the gate was closing.
- (4) On that day at the time of Isha prayer the door was knocked and we stripped our eyes and 2 to 3 persons came and took Naqeeb outside then we heard Naqeeb was screaming, we understand that they are torturing Naqeeb. After 40/50 minutes they again came and took me and also double the strip on my eyes, tied my hands on my back and opened the chain from my feet and lied me on a table and then tied me from feet to neck they put Naswar in my mouth and nose, they put cloth on my face and use to pure the water on the cloth which goes through my nose to the brain and I was feeling shocks.

- (5) Next day they striped eyes of both of us between Asar and Maghrib and seated us in a car and took us to the Sachal Chowki we offer prayer in that chowki and 2/3 persons came and took us in the office, where a person with long mustache was sitting, who said that "Both of you can leave as your life is spared and if you told someone that Naqeeb was with you then you will die." After some days on social media we saw that mustache person and came to know about his name i.e. Akbar Malah.
- (6) About 10.00 or 10.30 o'clock we were left at Super Highway. The police officers which I have seen from the first day till the last if I see any one of them again I will recognize him. When I heard the voice of the Rao Anwar on the Social Media I identified him that it was the same voice who was asking our name address and caste in that closed room, thereafter, through social media I came to know that Naqeeb has been killed by Rao Anwar alongwith his team in a fake police encounter. (the detailed Statement under Section 164 Cr.P.C. is enclosed).

The important points of the Statement under Section 164 Cr.P.C. of the eye witnesses and abductees Muhammad Qasim son of Dawood Khan are as under:

(1) On the 3<sup>rd</sup> of 4<sup>th</sup> day on Thursday Month January year 2018 at about 0245 o'clock I alongwith my friend Hazrat Qasim had gone to Al-Asif for purchasing clothes. There Hazrat Ali got a message from Naqeeb on messenger. When we were sitting at Sardar Hotel Naeeb through message called us at Sher Agha Hotel opposite Chappal Plaza we reached there at about 03.00 O'clock and met Naqeeb we sit in the hotel and Naqeeb give order to bring three cup of tea alongwith 4/5 pieces of cake and before the waiter could bring the order 8 to 9 persons in civil dresses came amongst these people some were wearing pant shirts while other were dressed in Shalwar Kameez, some of them had pistols in their hands and the others were holding Kalashinkov, they took us from there to Sachal Police Chowki forcibly on the gun point. They separated us from Naqeeb and took us to the other room. After about 40/45 Minutes a person came into the room and stripped our eyes he stripped my eyes tighter and when I complained for it he slapped me hard and took us to a car and seated us in that car, before sitting in the car when we asked them that where they were taking us they replied that we are taking you to Rao Anwar from where you will to go Jannat. After 40/4/5 minutes they took us out of the car and about 10 to 15 steps they asked us to sit on the ground and put chains in our feet and put locks on the chain and then took us to a room where they locked us and they told us that when the door will knock, you should understand that Rao Anwar has come and then close your eyes. when we opened our eyes we saw Naqee is also with us. Naqeeb then asked us that what have you done for which they have taken us here. He informed that he was very badly beaten by them and the police was demanding 10 lacs from him and he had informed that I am a poor person and don't have such amount.



- (2) That day passed and on the next day at Isha time the door was knocked and a person came inside the room he ask us to stand up and asked our names and took Naqeeb outside we heard the screams of the Naqeeb after 50 minutes a person came and took Hazrat Ali with him, then I heard his screams as well. After a while they doubled my strip and tied my hands on my back and took me outside and asked me about my work I informed that I have just came from Dubai he slapped me and lied me on a table he kept a cloth on my mouth and started pouring water containing naswar in my nose.
- (3) Next day about 11.00 or 1200 o'clock the door was knocked and as usual we striped our eyes, the person came inside and asked Naqeeb to come outside and took him outside. We were able to hear his screams in our room. When Naqeebullah came back he informed that they have tortured him very bad. After one hour the door was again knocked we stripped our eyes and a person again took Naqeebullah outside and after that I never seen him again. Next day they striped eyes of both of us between Asar and Maghrib and seated us in a car and took us to the Sachal Chowki, at the chowki we were locked in the lockup we offered the isha prayer and then they took us out of the lockup and get us to the office and removed the stripes from our eyes, in the office there was a person with long mustache, who said that "if you told someone that Naqeeb was also with you then you will die."
- (4) When on media I saw that Mustache on media I recognized him and his name was informed to be Ali Akbar Malah. On 17.01.2018 through media it came to know that Naqeebullah has been killed in fake police encounter by the Rao Anwar and his team. The police officers which I have seen if I see any one of them again I will recognize him. (the detailed Statement under Section 164 Cr.P.C. is enclosed).

During investigation Letters were issued to PEMRA and FIR to obtain the interview which were recorded at the place of incident on the day of incident by different news channels i.e. Duniya News, PTV News, Geo News, Samaa News, Dawn News, ARY News, Din News. From which Geo News Channels provided the same in the form of CD alongwith letter. The obtained CDs (Geo news, ARY news, Duniya News, Express News, Dawn news) were taken into police custody for preparing memo. On 06.02.2018 the arrested accused persons (1) ASI Allayar Kaka son of Juma Khan (2) HC Muhammad Iqbal son of Ahmed Yar 14694 (3) HC Khizar Hayat son of noor Muhammad 19451 were produced before the competent Court for recording of their statement under Section 164 Cr.P.C. who did not give any statement in the court. On Which the JM IV Mir Sagar Khan Abro Malir Karachi remanded the three accused persons to Jail Custody. Therefore the said three accused persons were admitted to Jail in compliance to the order of the competent Court. On 07.02.2018 the arrested accused persons (1) PC Arshad Ali son of Mazhar Ali 5648 (2) SIP Muhammad Yaseen son of Ahmed Yar (3) ASI Supurd Hussain son of Ghulam Hussain were admitted to jail by the Orders of the Administrative Judge ATC at High Court of Sindh on jail custody.



During investigation Video statement was recorded of HC Shahzada Jehangir 23851 posted at Police Station memon goth Malir Karachi. The summary of the statement is that he used to do the written work for Ex SHO Amanullah Marwat for every action and I also used to make message and give to Amanullah Marwat, after which he used to send these messages of the High-ups. Whenever some incident took place I used to reach their on his direction and used to do all written/reading work at the place of occurrence. On 13.01.2018 SHO Amanullah Khan Marwat through phone directed me to reach Sheedi Khan Goth and as per his direction I reached at Sheedi Khan goth where Amanullah Marwat (1) ASI Gada Hussain (2) HC Mohsin Abbas (3) HC Sadaqat Ali Shah (4) PC raja Shamim (5) PC Rana Riaz (6) PC Shakeel (7) PC bahadur were present. I met Amanullah when within 10 minutes a carvan of vehicles in which armored van of police and private vehicles were included. In these cars there was Ex SSP Malir Rao Anwar, Ex SHO Sohrab Goth Shoaib Shaikh @ Shoaib Shoter, ASI Khair Muhammad, WHC Faisal, SI Anar Khan and other police officers came out oand stand nearby that old poultry farm. One armored police mobile van stoped in front of that house and they took out four persons from that armored van whose faces were covered with clothes. Shoaib Shooter, Amanullah Marwat, WHC Faisal and Other Gunman took these four men inside the house. Meanwhile, Ex SDPO Malir City Qamar Ahmed Shaikh also came there and stand by the Ex SSP Rao Anwar and others near the said old poultry farm. After a while I heard firing from the rooms of that house. After 5/6 minutes Shoib Shooter, Amanullah Marwat, WHC Faisal and other gunman came out of that house and I was called by Amanullah to come and complete the written proceedings. I went inside and saw that there were two dead bodies lying in one room and two dead bodies were lying in the other room. I did the written work at the spot and came out. Thereafter Shoaib shooter did firing on the outer wall of the with SMG and on the spot the entire arms of the accused persons and fired bullets cases were collected by Amaullah Marwat and he kept them in his official APC vehicle. Thereafter, media reached at the spot and the Ex SSP Malir Rao Anwar held press conference on the spot and from the spot through ASI Saleem ahmed and other staff sent through Edhi and Chippa embulances for proceedings to Jinnah hospital. (the detailed statement of video recording is enclosed as evidence).

During investigation the detail statement of the father of the deceased Nazar Jam son of Atam jan was record. Who in his statement stated that I was present in my village when my son Akhter Jan informed me on phone that my son Nazar Jan has been called from his house at Janjal Goth by government officials in civil dresses and has been taken in their vehicles with them. I was inquiring my son Akhter jan about my son Nazar and every once and a while. Akhter Jan was informing me that he is getting information about him. I did not even notice and these officials on 17.05.2017 took my son after Maghrib prayers. Meanwhile, a period of seven months have been lapsed but I did not get any information regarding Nazar Jan. On 24.01.2018 my son Akhter jan informed me on my phone that Nazar Jan has received Shahadat with Naqeebullah, I remain in touch with my son Akhter Jan to take



the dead body of Nazar Jan to the village. On 26.01.2018 my son was buried in our native village after which were busy in Fatiha Khawani.

During investigation detailed statement of the cousin of the deceased Muhammad Sabir son of Muhammad Bux namely Abdul Qadir son of Abdul Ghaffar was recorded. Who stated that deceased Muhamamd Sabir son of Muhammad Bux was my cousin on 10.11.2016 I was informed by my family on phone that they have come to know from a news paper of Multan that my paternal cousin Muhamamd Sabir son of Muhammad Bux has been detained by police. Whereafter, we could not get any information till 14 months about Muhammad Sabir. On 01.01.2018 I went to my village in the province of Punjab I was in my village when I was informed by my relatives that in the jurisdiction of Police Station Lateef Town Karachi Muhammad Sabir has been killed in a fake police Encounter. On this information I alongwith my uncle Abdul Wahid came at Karachi and after getting the dead body we again went to Punjab. My uncle Muhammad Bux son of Khair Muhammad received notice from SSP Investigation II Karachi on the notice I came alongwith my uncle to Karachi we want legal action and justice be provided to us Muhammad Sabir was Hafiz e Quran, Muhammad Sabir has received the education of Quran-e-Pak at Karachi in Madarsa at Zia Colony Korangi Karachi and was living there thereafter he went to his village and after spending two months in the village, and left the village for Multan as he told us that he has got Mauazzin job in Multan. We don't know from what place in Multan he has been abducted and by whom he was abducted. (the detailed statement is enclosed)

Durving investigation Statement of Muhammad Ibrahim son of Raheem bux i.e. the brother of the deceased Muhammad Ishaq son of Raheem Bux was recorded. Who in his statement stated that on 10.11.2016 I was present at my house at Basti haji Kareem Bux Lang when at 1200 a.m. in the noon I heard the voice of disturbance and some Mohalla people came at my house and informed that two white color cars and two Dalay of police has came at the madarsa of Muhamamd Ishaq son of Raheem Bux, on this I alongwith other residents of the haji Karim Bux basti become frightened. They took my brother Muhammad Ishaq from his madarsa by covering his face with cloth they took him in one Dala with one white car, while One Dala and white car remained in our village, the persons available in the white car were dressed in civil clothes while the persons in the Dala were wearing police uniform. They conducted search of the house of my brother Muhammad Ishaq son of Muhamamd Zakariya these persons were connected with someone on phone and were saying that "you have misguided us' and in the evening about 0600 o'clock both the Dala in which the police in uniform were present and the white car left our village. Our mother kept on requesting and praying them when they took my brother and were searching the house of my brother Ishaq but they did not listen to my mother, they were given reference of Quran also. My brother Muhammad Ishaq was a good human being. He always spent his life in the light of Quran and sunnah as he was Aalim himself. And there was no any complain ever made by any one the inhabitants of our village nor by any other person from any other village. Further there was also no any complaint ever made by any agency, police officer or police



station against my brother. My brother had no relation of whatsoever nature with any political or religious group. My mother die in grieve of separation of my brother Muhammad Ishaq as she felt ill and could not bear the shock and died. My brother Muhamamd Ishaq was picked up from Punjab and was killed in fake police encounter within the juriof Shah Lateef two Karachi (Detailed statement is enclosed).

During investigation of the above case the high-ups vide order dated NO/Addl.IGP/Sindh/438-49/2018 dated 22.02.2018 a team of the officers was constituted that consist (1) DSP Jaffer Baloch (2) DSP Mehmood Hussain Raja (3) SIP Shakir Hussain (4) SIP Malik Muhammad Sarfaraz (5) ASI Shahzad (6) PC Imtiaz Hussain 25822 (7) PC Shafiq Ahmed 12855 in order to get criminal record of the deceased persons (1) Muhamamd Sabir son of Muhammad Bux (2) Muhammad Ishaq son of Raheem Bux to the district Bahawalpur. The team after investigation submitted their report to me investigating officer. The report states that Muhamamd Sabir son of Muhammad Bux was picked up by the government officials on 09.11.2016 due to some unknown reasons from Multan Shujaabad. While regarding the other deceased person namely Muhamamd Ishaq son of Raheem Bux he was picked on 10.11.2016 from basti Long Garwat post office Hyderpur Taluka Ahmedpur Sharqi District Bahawalpur by some 25/30 police officials who were either in civil dresses or in police uniforms. While the criminal records of both the deceased persons are silent nor there was any missing report available in any police station of court. Detailed report is enclosed.

During investigation on 11.02.2018 the accused persons 1. PC Ghulam Nazuk (2) Abdul Ali son of Allabachayo (3) Shafiq Ahmed son of Shafi Muhammad were formally arrested in the above case. The said three persons were produced before the Administrative Judge ATC and police Custody remand was obtained after which said three accused persons were interrogated and Photo Finger and CRO was done. During investigation on the pointation of PC Ghulam Nazuk 2. PC Abdul Ali son of Allah Bachayo and 3 Shafiq Ahmed son of Shafi Muhammad Memo of pointation of place of incident was compiled. The same is enclosed.

During investigation on 13.02.2018 the high-ups appeared before the Hon'ble Supreme Court of Pakistan in Suo Moto case. The non arrested accused Rao Anwar has written a letter to Supreme Court of Pakistan on which Chief Justice of Supreme Court has issued an Order in which it has been order to constitute a JIT and abstain from arresting the accused Rao Anwar. As up till Rao Anwar or any other accused has not appeared before the Hon'ble court on any of the hearing as such Hon'ble Supreme Court of Pakistan in its Order dated 16.02.2018 has issued a show cause notice against Rao Anwar, which is still pending before the Hon'ble court. It is has been further Order that Rao Anwar be arrested and letters be issued to seized the bank accounts of Rao Anwar to State Bank of Pakistan and other agencies are also directed to arrest Rao Anwar.



On 19.02.2018 the said three arrested accused persons were sent to the jail under Judicial Custody by the orders of competent court. During investigation on 20.02.2018, DSP Qamar Ahmed Shaikh SDPO Malir City was formally arrested in the above case. On 21.02.2018, police custody remand of the accused was obtained till 27.02.2018 from the Administrative Judge ATC Court at Sindh high Courts, who after the expiry of the police custody remand was admitted to jail under Judicial Custody by the Orders of the Court. During investigation FSL examination was carried out of the arms and ammunition recovered from the place of incident and the report is enclosed. During investigation statements of the heirs of the deceased person were recorded which are enclosed. The teams constituted by the high-ups upon the approval from the Home Department are conducted raid in different areas in different cities for the arrest of the accused persons.

SSP Rao Anwar and his team including DSP Qamar Ahmed have also made entries regarding the fake encounters. Entries and log books with reference to the case has been included in the case. Interview contradictions, are available on record. During investigation it has been established that DSP Qamar Ahmed was present at the time of incident and was involved in destroying evidences and entries and in facilitation of the crime. Ex SSP Rao anwar, Statement of the witnesses under Section 161 Cr.P.C. CDR location and the interviews of Rao Anwar received from the Media in form of CDS and the investigation carried uptill now clearly established that SSP Rao Anwar was the principle accused in the fake police encounter, he is proved to be the head of the of the team who were involved in the crime from abduction of the deceased Naqeebullah, Muhammad Ishaq, Muhammad Sabir and Nazar Jan till they were pronounced as fake terrorists.

In the above case after examination by the chemical examiner 3x Carpets and clothes of the deceased persons has been sent to forensic lab Lahore for examination of DNA Test. On receipt of the report the same shall be submitted before this Hon'ble Court. The map was prepared through Tapedar of the place of incident where the deceased were shown to be encountered in fake police encounter in FIR No. 17/18 under Section 353/324/34, PPC, R/W 3/4 of Exp Act R/W 7ATA of Police Station Shah Lateef Town, which is enclosed herewith. The CD of video recording statements of the eye witnesses of the case has been sent for forensic examination to FIR and for others CDS of Geo News, ARY news, Duniya News Dawn News letter has been sent to chairman PEMRA.

From the investigation, Memo of place of incident (Memo of examination of place of incident forinci report) Statement of the witnesses under Section 161 and 164 Cr.P.C. identification Parade against accused namely (1) ASI Allayar Kaka son of Juma Khan (2) SIP Muhamamd Yaseen son of Ahmed Yar (3) HC Muhamamd Iqbal son of Ahmed yar (4) ASI Supurd Hussain son of Ghulam Hussain (5) PC Arshad Ali son of Mazhar Ali (6) HC Khizar Hayat son of Noor Muhammad (7) PC Ghulam Nazuk son of Ghulam Akbar (8) PC Shafiq Ahmed son of Shafiq Muhamamd (9) PC Abdul Ali son of Allabachayo and absconded accused persons (10) ASI Ali Akbar Malah (11) PC Raees Abbas (12) PC

Syed Imran Kazmi have abducted the deceased Naseem @ Naqqeb Ullah son of Muhammad Kan and his friends Hazrat Ali and Muhammad Qasim, demanded for illegal money, illeal detention, torture is established. While Memo of place of incident (place of incident examination forensic report), forensic report regarding arms, digital evidences, technical reports CDR Locations, Interviews CDS of Rao Anwar received from the media, and other factual evidences clearly proved that under custody DSP Qamar Ahmed Shaikh son of Parvez Ahmed Shaikh and other absconded accused persons (1) Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan (2) Ex SIP Anar Khan son of Umer Hayat Tarar (3) Ex HC Faisal Mehmood son of Muhamamd Naib (4) Ex PC Raja Shamim Mukhtyar son of Raja Mukhtiyar Hussain (5) Ex SIP Amanullah Marwat son of Saeedullah Khan (6) Ex ASI Gada Hussain son of Faiz Muhamamd Sugrani (7) Ex HC Sadaqat Hussain Shah son of Ghulam Husain Hamdani (8) Ex HC Mohsin Abbas son of Noor Zaman (9) Ex PC Rana Riaz Ahmed Fiaz Ahmed Rana (10) Ex SIP Shaikh Muhammad Shoaib @ Shoaib Shootar son of Shaikh Asghar Ali (11) Ex ASI Khair Muhamamd son of Jamaluddin and other accused persons has killed the deceased persons extra judicially, and pronounced them as members of banned organizations while there is no previous criminal record of the deceased persons, furthermore, the deased Nazar Jan was shown to be the gunman of Hakeemullah Mehsood, giving protection to their illegal extrajudicial killings by highlighting fake incidents through media channels, destruction of the evidences, misuse of authority, all has been established, the purpose behind which was to strengthen their illegal and evil designs. In the above case in order to arrest the non arrested accused persons, help of print media and social media is also obtained. Assistance of the intelligence agencies has also been sought, the accused persons of the above crime are intentionally hiding in order to save themselves from the legal arrest, whose search is continued.

In view of the above facts and circumstances and evidences the offences under Section 365-A/302/114/344/34/342/201/202/220 ppc is established against the accused persons arrested and non arrested. In the above case after the conclusion of the investigation the final challan is hereby submitted for hearing of this Hon'ble Court.
