

**REPORT OF JOINT INTERROGATION TEAM (JIT)  
ON INTEZAR MURDER CASE - FIR NO:16/2018 U/S 302/34  
PPC OF PS DARAKHSHAN DISTRICT SOUTH.**

In compliance of the order of Home Department, Government of Sindh vide Notification No.SO (LE-I) 08-04/2018 (JIT) dated, 12.02.2018, a joint interrogation team was constituted in case FIR No 16/2018 u/s 302/34 PPC of PS Darakhshan - murder of Intezar Ahmed s/o Ishtique Ahmed (**Annexure-I**). **1. BRIEF FACTS OF THE CASE.**

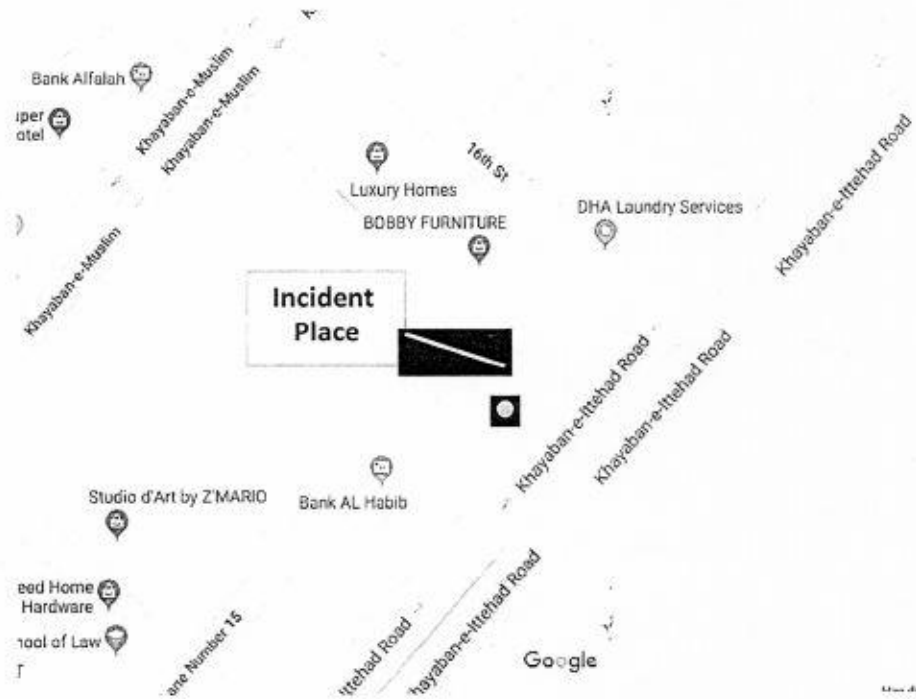

On 13<sup>th</sup> Jan 2018 at 1928 hours, a call was received on Madadgar 15 from Mr. Saafi Cell No 0336-8440435 that a boy has been injured in firing near Khayaban-e-Ittehad/Bukhari Commercial Area opposite Castle lights.

The duty Officer reached the spot and shifted the injured to Jinnah Hospital in Chipa Ambulance. The boy, who was identified as Intezar Ahmed s/o Ishtiaq Ahmed aged 19 year, was pronounced dead by the Medico Legal Officer (MLO).

Complainant Ishtiaq Ahmed s/o Khalil Ahmed stated in his statement that he is a businessman and Intezar Ahmed was his son. He was studying in Malaysia, and on 29.11.2017, he had returned back to Karachi. On 13.01.2018 at 5.30 pm he went out in his car bearing Registration No.BLE-254, Maker Toyota Crolla Grande to meet his friends in Defense. At about 8.00 pm he was informed by his neighbor Fahad that Intezar was shot injured and shifted to Jinnah Hospital. He along with his relatives reached the Hospital, where Doctors declared his son dead. His postmortem examination was held. He came to know that on 13.01.2018 at 07:15pm, unknown accused persons shot/killed his son at Lane-V near Castle light Bukhari Commercial Phase VI DHA Karachi. Hence, case was registered against unknown accused persons. ( Copy of FIR at Annexure-II)

S.I Arshad Ali of Darkhshan PS along with police party rushed to the place of incident i.e. Lane-V near Castle light Bukhari Commercial Phase VI DHA Karachi where he secured 18 empties of 9mm and one slug.

Before the registration of case on the complaint of father of Intezar, SHO/ACLC Inspector Tariq Mehmood, came at Darakhshan Police station along with a statement u/s 154

#### **4. FORENSIC EXAMINATION OF RECOVERED WEAPON.**

Eight recovered 9mm pistols along with 18 empties of 9mm pistol were sent to Forensic Lab for examination/analysis which revealed that 06 crime empties were fired from Pistol No.T1102w-17E02748 recovered from accused Muhammed Daniyal in view of the fact that major points i.e striker pin Marks and breech face marks are "Similar", while 12 crime empties were fired from Pistol No.AAYB-803 which was recovered from accused Bilal Rasheed in view of the fact that major points i.e striker pin Marks and breech face marks are "Similar". (Annexure-V)

#### **5. PROCEEDING OF THE JIT.**

Six Sessions of Joint Interrogation Team were held as below:

- 1st meeting was held on 19.02.2018 at 1200 hrs in the office of Addl IGP CTD Sindh.
- 2<sup>nd</sup> meeting was held on 21.02.2018 at 1600 hrs in the office of the DIGP South Zone Karachi.
- 3<sup>rd</sup> meeting was held on 23.02.2018 at 1400 hrs in the office of Addl IGP CTD office.
- 4<sup>th</sup> meeting was held on 01.03.2018 at 1600 hrs in the office of Add IGP CTD Sindh.
- 5<sup>th</sup> meeting was held on 02.03.2018 at 1500 hrs in the office of Add IGP CTD Sindh.
- 6<sup>th</sup> meeting was held on 03.03.2018 at 1200 hrs in the office of DIGP South Zone Karachi.

As part of its proceedings, the JIT members examined the complainant and relevant witnesses and recorded their statements (written and video). In addition to this the investigation of the case so far was perused and case file was examined in detail. The CCTV footage of the incident was viewed in detail. In addition to this the CDR of the police officials involved in shooting and the nominated suspects was analyzed. The members of the intelligence agencies on JIT also provided their formal and informal input on the matter.

#### **6. STATEMENTS RECORDED BY JIT.**

The following were examined during the course of the JIT proceedings:

Cr.P.C as well as arrest & seizer memo for registration of case u/s 319/34 PPC. He informed that the incident took place during vehicle checking by firing of officials of ACLC. He nominated sub ordinates of ACLC. However, the local police did not register the case on the complaint of SHO ACLC, instead informed Mr. Ishtiaq about the incident. However, Mr. Ishtiaq preferred registration of case against unknown accused for unknown motive.

## **2. POLICE INVESTIGATION.**

After registration of case investigation was entrusted to SI Muhammad Ashraf Jogi, who prepared the inspection memo as well as recorded the statement of witnesses and arrested the eight Police Officers/Officials of ACLC. Whereas, ninth Officer Inspector Tariq Raheem joined investigation after obtaining pre-arrest bail.

On 15<sup>th</sup> January 2018, the video footage of the incident was obtained and the DVR was also seized. The CCTV footage very clearly shows the complete incident. The footage was shared with Mr. Ishtiaq Ahmed and his sister.

On 18<sup>th</sup> January 2018, Inspector Nacem Awan, SIO Darakhshan, returned back from casual leave and took over investigation. On the orders of Inspector General of Police, investigation of the case was entrusted to SSP Investigation-I Mr. Farooq Awan. Subsequently, on the request of the father of the deceased the investigation of the case was transferred to Mr. Amir Farooqi, PSP DIG CTD Sindh Karachi, vide letter No.2936-42/AIGP/OPS/III/2018 dated 22.01.2018. (Annexure-III)

On 12.02.18 Home Department Govt of Sindh constituted the current JIT headed by Add IGP CTD and representatives of Police, ISI, IB, Rangers, Special Branch and MI.

During the course of investigation, CDRs in respect of cell phones of SP Muqadas, Haider and Mst. Madiha Kiayani were obtained and analyzed but no such link between them was found. Mr. Sohail father of Ms. Mahrukh was contacted through his WhatsApps number 0018325810815, who stated that they are in USA. Travel history was obtained from FIA immigration, which revealed that Muhammed Sohail departed for USA on 5<sup>th</sup> May 2017 and Mahrukh on 18<sup>th</sup> August 2017 and never returned back to Pakistan and they denied any relationship with SP Muqadas Haider.

SSP Muqadas Haider in his statement denied the relationship with Muhammad Sohail and his daughter Mahrukh as well as Madiha Kiyani.

## **3. FORENSIC EXAMINATION OF THE CAR.**

Forensic examination of Car No.BLE-254 was carried out vide No.AIG/FD/OR/F.A/511/2018 dated 23.01.2018 by AIGP Forensic Division Sindh Karachi, (Annexure-IV) which led to the opinion that:-

- a) The hole marked as ENT-1(right side rear window glass) ENT-2(right side back door) ENT-3(right side rear under mudguard)
- b) Two scratches marked as S-1(right side back door) and S-2 (right side of rear bumper near tire) are caused due to slip of fired projectile of fire arm.

i. **STATEMENT OF COMPLAINANT ISHTIAQ AHMED S/O KHALIL AHMED.**

The JIT members heard Mr. Ishtiaq Ahmed in detail. He attended the proceedings alongwith his lawyer Mr. Asif Khudai Advocate. After receiving the dead body of my son I visited PS Darakhshan at about 01:00 am on 14.01.2018, however, no senior office was there and only a Constable was present there. At about 04:00 am a SI recorded my statement and handed me the FIR at 11:00 am. After burial my relative and friends informed me about the news on media that my son was killed by the firing of ACLC officials. On 16.01.2018 I visited the place of incident and also visited the Crystal light shop and asked about the CCTV footage. They informed that the DVR has been taken away by Police. In the evening the Police officials shown me CCTV footage on a laptop. In his statement he showed his suspicion on the girl that was present with Intezar on the day of incident, later identified as Madiha. It came to his knowledge that some one known to Madiha did not like her meetings with Intezar. Madiha had informed about this to one of the friends of Intezar. He also suspected SSP Muqadas Haider as his PSO/Gunmen killed his son. He also stated that his son Intezar had a class fellow friend namely Mah Rukh, daughter of Muhammad Sohail during School days. Mr. Sohail did not like this and he threatened him on phone to stop his son to contact her daughter. Mr. Sohail had also informed him that his brother is working in Police department as DSP or SP. Mr. Ishtiaq asked to check the CDRs of the individuals involved. He suspected that his innocent son was murdered after a planned conspiracy. (Statement at Annexure-VI)

ii. **STATEMENT OF INSPECTOR K-1896. TARIQ MEHMOOD**

He stated that he is posted as SHO ACLC since 15-09-2017. Due to increase in the crime in the area of DHA, as per strategy they had deputed various parties of ACLC in the vicinity and he was also present for checking. On 13-01-2018 he was present in the area of DHA, when spotted Car # 987 coming from Ittehad towards Khayaban Bukhari. He

informed the superiors and alerted the personnel deputed for duty. During the course of checking he went to the tea shop adjacent to the Master Juice, where Inspector Azher and Inspector Tariq Raheem were present along with sub ordinate staff and M/Cycle patrolling parties were on patrolling. In the meanwhile, PC.Fawwad informed Inspector Tariq Raheem through Phone about presence of a suspected car in the area of Khayaban Bukhari. In the meanwhile PC.Bilal and PC.Daniyal came there and brought his Diary, Cap and internet device, which he had left in his office. Thereafter, they went along with Inspector Tariq Raheem to the area and when they reached at Khayaban Muslim and stopped near the suspected car. In the meanwhile others and Inspector Tariq Raheem asked the subordinate staff to let him go. As soon as the car turned towards Khayaban he heard sound of firing, and he screamed to stop the firing. In the meantime the car turned towards Khayaban Ittehad after crossing the footpath and the subordinate staff went away. They were stopped and their weapon was confiscated and he along with Inspector Tariq Raheem went to the scene of offence, where public had gathered and the injured was being shifted to the Hospital. In the meanwhile they confiscated weapon of HC. Shahid, PC. Fawwad and PC.Ghulam Abbass, while HC. Ghulam Abbass was without weapon. He further deposed that statement u/s 154 Cr.P.C was against HC.Shahid, PC.Fawwad PC. Ghulam Abbass, PC.Bilal and PC.Daniyal and they confiscated their vehicle and came to PS Darakhshan along with other officers and officials. (Statement at Annexure-VII)

iii. STATEMENT OF INSPECTOR AZHER HASSAIN.

He stated in his written statement that he is posted in ACLC and on 13-01-2018 he was deputed by SSP ACLC for control over the crime in Bukhari Commercial Area of PS Darakhshan. He along with Inspector Tariq Raheem and officials was on duty in his private vehicle while Inspector Tariq Raheem was also present at Master Juice. In the meanwhile they received information about presence of a suspected Toyota Car in the vicinity. On this information he along with Inspector Tariq Raheem reached where said car # BLE-254 was stopped. On seeing, he cleared the car and asked to let him go. As soon as the car turned to the right he heard sound of firing and after a while the car stopped. They reached at the place of incident and an Ambulance also reached there. The injured was shifted to the Hospital and he enquired from the officials Bilal and Daniyal about the firing and he confiscated their weapon. He further deposed that they were not deputed for duty along with them. They were identified as 1.HC.Ghulam Abbass, HC. Shahid, PC. Abbass and PC Fawad. Ghulam Abbass was not having weapon while the remaining 3 were having Pistols. He confiscated their weapons. In the meanwhile SHO Darakhshan also reached there and they went to PS Darakhshan. (Statement at Annexure-VIII)

iv. STATEMENT OF INSPECTOR TARIQ RAHEEM S/O FAZAL RAHEEM.

He stated in his statement that since 2011 he is posted at ACLC as Addl. SHO. On 13.01.2018, he was present at ATC Clifton when he received telephonic message from ACLC office Artillery Maidan that as per direction of high ups, he along-with Insp. Azhar Hussain will perform duty in plain clothes at Bukhari Commercial Area of PS Darakhshan to prevent snatching of vehicles bearing Government Registration numbers. He reached at Master Juice where SHO ACLC/Insp. Tariq Mehmood was present. PC/Fawad informed him through cell



phone that a white Toyota car is present behind a Government Vehicle inside street in the area of Bukhari Commercial. On this information he along-with Insp. Tariq Mehmood reached there where one white Toyota corolla with tinted glasses & temporary number plates was spotted. They intercepted the car near Castle Light shop lane No.5. In the meantime, Insp. Azhar Hussain reached there in his car and after checking he allowed the driver to go. As soon as the car moved forward, constables Bilal & Daniyal who suddenly reached in front of the car, started firing upon the car. SHO ACLC Insp. Tariq Mehmood shouted loudly not to fire. Right after this incident both the above named constables fled away on their M/ Cycle. Subsequently, Insp. Tariq Mehmood took the weapons of constables who were present a little away from place of incident. He himself was armed with his personal 9mm pistol but he did not fire a single round in this incident. (Statement at Annexure-IX)

**v. STATEMENT OF PC SHAHID S/O USMAN GHANI.**

He deposed in his statement that he was enrolled in Police Department as Constable in 2003 and after qualifying recruitment training he was posted at District South and 3/4 months ago he was posted at ACLC. He was having a licensed 9 mm pistol and he use to carry the same during official duty. On 13-01-2018 at 1200 hours he joined duty at PS ACLC and as per direction of SHO he along with HC.Ghulam Hussain went to Bukhari Commercial area and reported to Inspector Azher Hussain. Besides him, Constable Fawad and Ghulam Abbass were also deputed there. They were deputed to trace a Toyota corolla car grande white colour with sun roof having No.987. At evening while they were gathered at tea hotel near Master Juice to take tea, and in the meanwhile same car passed through, and he along with Constable Fawad and PC. Ghulam Abbass chased him while HC.Ghulam Abbass was in the wash room. At some distance from Ajwa Hotel the said car stopped beside a white official corolla car. On this PC Fawad informed Inspector Tariq Raheem. In the meantime Inspector Tariq Raheem and Police Party reached there and knocked at the door to open the gate, but he didn't and went towards Korangi road. He and PC Fawad chased. PC.Bilal and PC.Daniyal also tried to stop the car but instead stopping he raced his car. In the meantime he saw PC.Bilal firing on the car. He did not fired from his pistol. (Statement at Annexure-X)

**vi. STATEMENT OF HC. 24689. GHULAM ABBASS S/O NIAZ ALL.**

He stated in his statement that he is posted in ACLC since last 2 years. On 13-01-2018, he joined his duty at 1200 hours and as per directions of SHO Inspector Tariq Mehmood went to Bukhari Commercial along with HC.Shahid, where he reported to Inspector Azher Hassan. Besides them, constable Fawwad and Ghulam Abbass have also reported there. They were in search of a white Toyota corolla car, which was reportedly involved in snatching offences. At evening they gathered at a Tea shop near Master Juice, where SHO inspector Mehmood, Inspector Tariq Raheem, PC. Fawwad and PC.Ghulam Abbass were also present. They took tea. In the meanwhile he went to washroom and when returned the police party was not found there. He contacted Shahid who told him that they are chasing a suspicious white car and asked him to stay at the hotel. After 10/15 minutes HC.Shahid returned back and stated that a problem has arisen and directed them to report back at PS ACLC. In pursuance of the directions they returned back to PS. On the way

HC.Shahid informed him that PC.Bilal and PC.Daniyal have fired upon the car, as a result one person sustained bullet injuries. Thereafter he along with Inspector Tariq Mehmood and others appeared at PS Darakhshan, where they were arrested accordingly. (Statement at Annexure-XI)

**vii. STATEMENT OF PC FAWAD KHAN**

He stated in his statement that he is posted at PS ACLC for the last 1 month. On 13-01-2018 at 1200 hours he reported at duty and as per directions of SHO he reported to Inspector Azher Hassan at Bukhari Commercial where HC.Shahid, HC.Ghulam Abbass and PC.Ghulam Abbass were also present. They were in search of a white Toyota corolla car which was reportedly involved in snatching of government vehicles. At evening they gathered at a Tea shop near Master Juice, where SHO inspector Mehmood, Inspector Tariq Raheem, PC. Fawwad and PC.Ghulam Abbass were also there. At evening a suspicious white corolla car was spotted and he along with HC.Shahid and PC.Ghulam Abbass chased the car, which was stopped, where they reached and he knocked at the door, but the driver didn't opened the door, and the driver tried to race his car, but in the meantime PC.Bilal and PC.Daniyal reached there and started firing on the said car. Inspector Tariq Mehmood forbidden them to stop the firing, but firing didn't stopped, thereafter the car went away. Thereafter Inspector Tariq Mehmood seized their weapon and they returned back to the P.S, while PC.Bilal and PC.Daniyal went to their homes. Thereafter he along with Inspector Tariq Mehmood and others appeared at PS Darakhshan, where they were arrested accordingly. (Statement at Annexure-XII)

**viii. STATEMENT OF PC GHULAM ABBASS S/O GHULAM RAZA.**

He stated in his statement that he is posted at PS ACLC for the last 4/5 years. On 13-01-2018 at 1200 hours he reported at duty and as per directions of SHO he reported to Inspector Azher Hassan at Bukhari Commercial where HC.Shahid, HC.Ghulam Abbass were present while PC.Fawwad also reached there. They were in search of a white Toyota corolla car, which was reportedly involved in snatching of government vehicles. At evening they gathered at a Tea shop near Master Juice, where SHO inspector Mehmood, Inspector Tariq Raheem were also present. At evening when they were taking tea a suspicious white corolla car was spotted. HC.Shahid and PC.Fawwad chased the car, while he informed inspector Tariq Raheem and they all went behind the said car, but HC.Ghulam Abbass didn't accompany them as he was in wash room. When they reached at Ajwa Hotel the said car was present there. Inspector Tariq Mehmood, Inspector Tariq Raheem, Inspector Azhar Ahsan and HC.Shahid were present there. In the meantime the car raced the car PC.Bilal started firing on the said car, while Inspector Tariq Mehmood and other officers were asking them to stop the firing, but they didn't stop. Thereafter, Inspector Tariq Mehmood seized their weapon and they returned back to the P.S, while PC.Bilal and PC.Daniyal went to their homes. Thereafter, he along with Inspector Tariq Mehmood and others appeared at PS Darakhshan, where they were arrested accordingly. (Statement at Annexure-XIII)



... came out from Police Club. SHO Tariq Mehmood who came to attend a meeting with PC. SSP at Police Club, had forgotten his Cap, Diary and Internet Device. He and PC. Daniyal went to the Master Juice, bukhari Commercial DHA on motorcycle to deliver the above articles to Inspector Tariq Mehmood. Both of them were armed with official 9 mm Pistols. In the meantime while they were delivering the articles to SHO, he received a phone call that the suspect car is present in the nearby street an offence is taking. On this Inspector Tariq Mehmood asked all the officials to rush to the scene of offence and they also went along with them on their own vehicles. When we reached lane 5 near Castle lights we found that Insp Tariq, Insp Azhar and Insp Tariq Raheem and their team had stopped a white coloured car with tinted glasses. At some distance they stopped and saw that the car driver reversed his car and rushed. HC Shahid and PC Fawad signaled the vehicle to stop. Daniyal after stopping the motorcycle came in front on road. As soon they came on the road, firing started and they felt that someone is firing on them. He fired on the tire of the suspected Car, but it went ahead and he went to the motorcycle firing in the air. Nobody ordered him to fire and he fired at his own. The car stopped after hitting the median. After this SHO Tariq Mehmood called him. He along with Daniyal also went to their homes. On the way SHO Tariq Mehmood asked him and asked about his whereabouts. He informed that he was after him but he was not sighted. So he advised them to go home. He and Daniyal went to the Frere Police Lines. He left Daniyal at his home and himself went to his home. He further deposed that he fired 2/3 bullets while he doesn't know about the firing of Daniyal. Later on he came to know that a person was killed in the last night incident and all the officers/officials are held at PS Darakhshan and he went there to offer his arrest. (Statement at Annexure-XVI)

x. **STATEMENT OF PC MOHAMMAD DANIAL S/O MOHAMMAD NAEEM AZAM**

He stated in his statement that he is posted at Security Zone-II and performing duty with SSP ACLC as gunman. On 13-01-2018 at 1730 hours, after duty he along with PC Bilal Rasheed came out from Police Club. SHO Tariq Mehmood who came to attend a meeting with SSP had forgotten his Cap, Diary and Internet Device. He and Bilal Rasheed went to the Master Juice on motorcycle to deliver the above articles to Inspector Tariq Mehmood. In the meantime while they were delivering the articles to SHO, he received a phone call that an offence is taking place in the next street. Hence they rushed to the scene of offence on their own vehicles and they followed Tariq Mehmood and went to the Ittehad road, where said Car was stopped. At some distance they stopped their motorcycle. He stood with the bike and PC Bilal Rasheed came in the middle of road. In the meanwhile the car rushed and firing started. The car was having tinted glasses. Bilal was having official 9 mm pistol who started firing. He also fired 2 bullets. One hit the tire while the other one hit the road. They saw that everyone was running. They also followed Tariq Mehmood but after some while he disappeared and they went to their home at Frere Police Lines. On 14-01-2018 they came to know that a person has expired in the last night incident and officers and officials of ACLC are held at Darakhshan. (Statement at Annexure-XV)

xi. **STATEMENT OF SSP MUQUDUS HAIDER.**

He stated in his statement that he has been performing duties as SSP ACLC/CIA Karachi since 10th September 2017. Due to sudden increase in incidents of car snatching of latest model government vehicles, specifically in the area of Clifton & Defence Housing Authority, Karachi, ACLC had initiated vehicle checking program in the affected areas and for the said purpose a program was issued vide his office letter No. SSP/ACLC/RDR/ 350 dated: 9th January 2018. The program elaborated deployment of ACLC personnel in proper uniform, under supervision of respective DSPs/In-charges (Copy enclosed as Annexure-XVI). In addition to internal distribution the same was also circulated to DIG CIA and DIG South offices for proper dissemination of information. He further added that in this connection a briefing/meeting on incidents of Car Snatching and ACLC deployment in the locality of DHA and Clifton was also organized by him for District South Police, which was attended by SP Clifton Division and SHOs of all six affected Police Stations where deployment was being made in order to keep the local Police in the loop. DSP Admin ACLC was the focal person for ensuring smooth and timely deployment of personnel.

He further added that in this regard briefing/meeting was also held at ACLC, in which all concerned personnel including In-charge South Zone and Inspectors working on cases were thoroughly briefed on case investigation and surveillance of the affected locality. They were directed/ordered not to intercept or obstruct any suspicious/doubtful vehicle without uniform and proper visible police identification, and in case of any information or observance of suspicious vehicle the same should be reported to the closest vehicle checking point in the area as issued vide above said order or to local police. The directions were at length stressed upon during the said briefing.

He further deposed in his statement that on 13th January 2018 after the incident, the known facts were immediately brought on record and communicated to the relevant/concerned authorities and available police personnel involved in the incident were detained and handed over to the Local Police. Moreover 03 officials initially not apprehended and out of which 02 personnel who were off duty at the time of incident namely PC. Bilal and PC. Daniyal deputed for escort duty with him were called by SHO ACLC Inspector Tariq Mehmood to the instant area on his personal terms. Both were also taken into custody by authorities next day, whereas remaining 01 personnel namely Inspector Tariq Raheem joined the investigation after pre-arrest bail. He further added that as a supervisory officer all the required actions were taken by him such as communication of known facts to senior command as well as local Police authorities, custody of available involved police officials and subsequent handing over to local police, while departmental action against delinquent officials was already initiated by DIG CIA vide order No. DIGP/CIA/DP/ 785-90 dated: 14-01-2018 (Annexure-XVII). On questioning SSP Muqudas Haider stated that Madiha Kiyani or Mahrukh is neither known to him or related to him.

( Statement at Annexure-XVIII)

xii. **STATEMENT OF INSPECTOR MOHAMMAD AAMIR HAMEED:**

He deposed that he is posted at Investigation-I South Karachi, while his brother Mohammad Suhail Hameed is settled along with his family in USA and doing business since last 3 years. On 22-02-2018 Suhail contacted him through what's app and informed him that Inspector Aziz Ahmed Sheikh of CTD contacted him and informed him that complainant of Intezar Murder case, Ishtiaq Ahmed has claimed that Mah Rukh D/O Suhail was studying in the school with deceased Intezar Ahmed. Sometime back Suhail called him and informed him that his brother is SP in police threatened him to stop Intezar to contact Mah Rukh. His brother further contended that on query of Insp Aiz Sheikh he confirmed that 2 ½ years ago he has contacted Ishtiaq Ahmed and complained against his son, who was making telephonic calls to his daughter in USA and Ishtiaq Ahmed has apologized, and confirmed that he has also received such complaints and he has sent his son to Malaysia for further education. His brother further deposed that he has neither threatened him nor stated about his brother. Thereafter, he contacted Inspector Aziz Ahmed Sheikh and recorded his statement. (Statement at Annexure-XIX)

xiii. **STATEMENT OF MADIHA KIYANI D/O SULTAN MASOOD KIYANI.**

She stated in her statement that she is living at Khyaban-e- Tufail Phase VII- Extension DHA Karachi and by profession is a Chef and used to perform cooking shows at several TV channels. In the month of January-2018, she was introduced to Intezar Ahmed by her friend namely Suleman. She asked Intezar Ahmed to arrange her job in TRG call center. On 13.01.2018, in the evening, Intezar send her a message to get ready for outing. Intezar picked her from home and they were roaming in Defense. When they reached Bukhari commercial near Castle light at about 07:30pm, they were intercepted by a car, while other car stopped on the left side of their car. As soon as Intezar reversed the car, someone cried that stop this car and she heard fire shots. She ducked down from the seat to the floor. When the car stopped, she called Intezar but there was no reply as such she understood that he was hit by bullet. She called Suleman on his cell phone that was attended by his mother and she told her about the incident. Due to fear, she escaped by hiring an auto rikshaw and reached home. She also informed her friend Awais. She stated that she knows no one in Police Department. SSP Muqudas Haider is neither known to her nor related to her. She came to know about his name on TV after this incident. (Statement at Annexure-XX)

xiv. **STATEMENT OF SULEMAN MUNAF S/O MUHAMMAD MUNAF**

He stated in his statement that Intezar s/o Ishtiaq Ahmed was his neighbor and childhood friend. Madiha Kiyani was friend of my friend Owais. Since November 2017 Madiha also became his friend. Since January 2018 Intezar also engaged in friendship with her through him. In the morning of 13.01.2018 he had breakfast with Intezar and we had planned to go out together in the evening. However, he had to go to Tariq Road with his mother. At 8 P.M he was along with his mother was taking bread at Rizwan kabab House DHA Phase-II and his phone was in the vehicle. In the meanwhile Madiha called at his phone and told his mother that Intezar has received bullet injuries. On this he called back Madiha, but she didn't received his call. When he reached home, he again called Madiha

who told him that after taking Burger from Nishat, and after meeting Intezar's friend at Bukhari, their car was intercepted by some persons, who started firing on them. As a result Intezar received injuries and she took Rickshaw and reached home. Thereafter he called Intezar at his cell phone, which was attended by SHO Sahil, who informed him that Intezar has been shifted to Jinnah Hospital. He called Intezar's father but his phone was powered off. On this he contacted Fahad a neighbored of Intezar, and asked him to inform family of Intezar. (Statement at Annexure-XXI)

xv. **STATEMENT OF SAAD ELAHI S/O SAJID ALI**

He stated in his written statement that he knows Intezar Ahmed s/o Ishtiaq Ahmed for the last 4/5 year and had good friendship with him. On 13-01-2018 @ 07:10 PM he along-with a friend Kaleem Ullah was sitting in his car near Ajwa restaurant where Intezar arrived in his car and met him. A girl was sitting with Intezar in his car. He asked about the girl on which Intezar told that she is his friend. After this Intezar went from there. He reached home at 09:00 pm and a friend Sameer Gulzar informed him that Intezar has died in a firing. He couldn't believe this. However, after a while he sent him photographs of bullet-hit car of Intezar. On this he and his friends reached Jinnah Hospital and found Intezar's dead body. He further added that Intezar had no conflict/ personal enmity with anyone. (Statement at Annexure-XXII)

xvi. **STATEMENT OF WAKEEL AHMED S/O KHURSHEED AHMED**

He stated in his written statement that he has is Masters in Psychology and serving in Willing Ways Hospital as addiction counselor. He knows Intezar Ahmed since March 2016, when his father admitted Intezar in his Hospital because of habitual drug addiction. For about a month Intezar remained admitted in the hospital. However, his parents discharged him from hospital during treatment. Intezar's father informed that his treatment remained incomplete, due to which he again started using drugs. Intezar's father discussed his condition and intended to admit him again in hospital, but Intezar started misbehaving with him. He complained to Intezar's father, who apologized for his son's behavior. Intezar started abusive phone calls to him and gave him threats for dire consequences even from Malaysia. When he returned from Malaysia he threatened him again. As a precautionary measure, he submitted an application against Intezar at PS Defence (Copy enclosed as Annexure XXIII). On New Year night, Intezar arrived in Hospital. He was drunk and broke headlights of one of the Hospital employee's car. After this incident Intezar's father apologized again for his son's behavior and after that Intezar did not make any contact with him. On 14-01-2018, he got news about Intezar's murder (Statement at Annexure-XXIV). Dr Wakeel informed that he came to know that a case was registered against Intezar at PS Airport when he did not stop at ASF security post and misbehaved with them and obstructed them in performance of their duty. (Copy of FIR lodged at PS Air port is attached as Annexure-XXV)

xv. **STATEMENT OF MR.SOHAIL HAMEED S/O ABDUL HAMEED**

Muhammed Sohail Hameed s/o Abdul Hameed aged 50 years, CNIC No.42201-6731213-5 r/o Huston Texas USA stated in his statement, recorded through video link, that he



along with his family is living in USA for the last three years and doing business. His children are studying in USA while his parents and younger brother Aamir Hameed are living in DHA Karachi. Aamir Hameed is serving in Police Department. His daughter namely Mahrukh Sohail aged 20/21 years was studying in City School Darakhshan Campus and completed "O" level and "A" Level, where a student namely Intizar was her class fellow. When his family shifted to USA his daughter Mahrukh told him that his class fellow Intezar often phoned her. He called Intezar on his phone in Malaysia and advised him and also got phone number of his father and talked to his father and complained that his son is making calls to his daughter unnecessarily and requested him to advise his son not to do so. In reply, Mr. Ishtiaq said that he himself was worried about him and had sent him to Malaysia for further studies. He further disclosed that Intizar being lonely son is disturbed after the death of his mother. Mr. Ishtiaq even invited to come over to his place on his next visit to Pakistan.

He stated that since the matter was resolved, he did not discuss this with anyone, not even his brother. He watched the news about murder of Intizar on T.V in USA.

After few days, Inspector Aziz Shaikh contacted him on phone and enquired about telephonic conversation with Mr. Ishtiaq and threats to him. He briefed him about the conversation with Mr. Ishtiaq and also informed his brother Aamir Hameed.

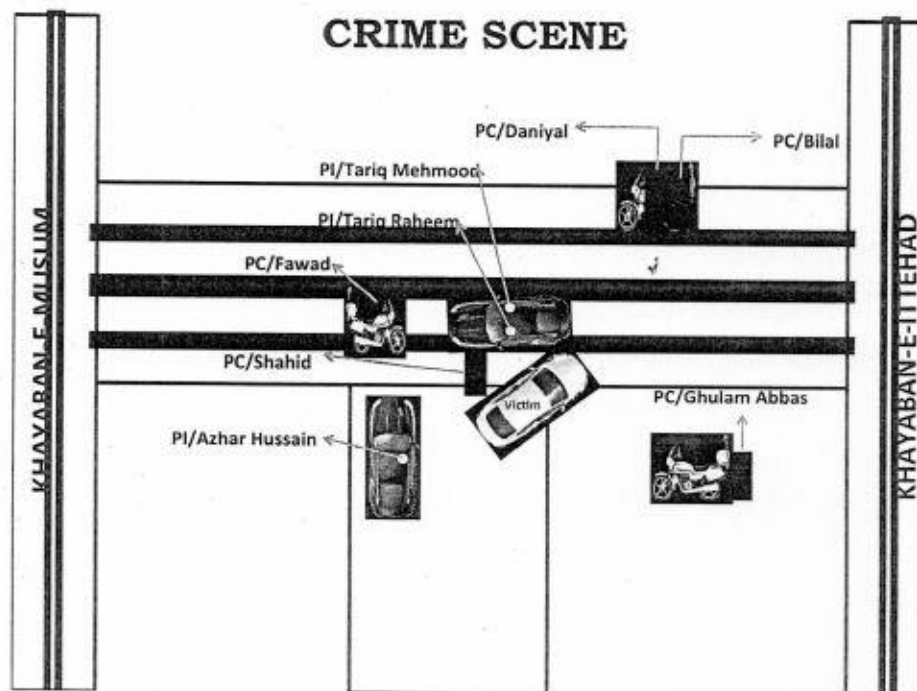
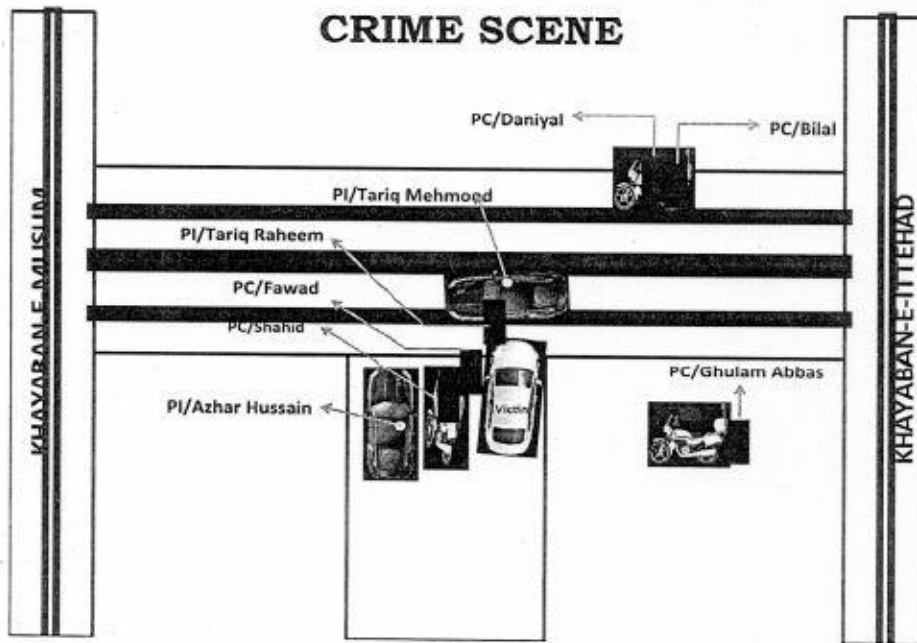
## **7. EXAMINATION OF CCTV FOOTAGE.**

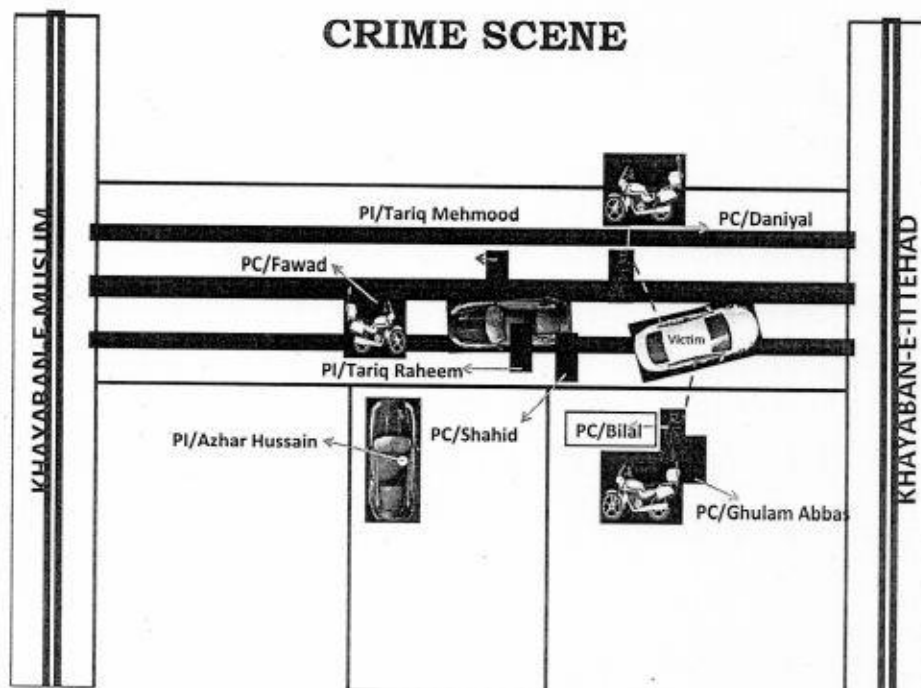
The JIT members viewed the CCTV footage of the incident in detail. It shows that Intezar's car was intercepted/blocked from the front by a dark coloured unmarked vehicle of ACLC. Another car followed him from the rear and stopped adjacent to his car. Two ACLC officials in plainclothes riding a bike approached him from behind/passengers side and an ACLC official on another motor cycle approached him from the driver side. However, they did not open the doors or checked /searched the vehicle. The footage shows that the ACLC officers in two cars and two motorcycles started retreating. In the meanwhile Intezar started to reverse the car and tried to move to the right towards Khayaban e Ittehad. Two other ACLC officials - Bilal and Daniyal - who were Gunman of SSP ACLC riding a motor cycle who had reached the scene from main Khayaban e Ittehad, could be seen approaching Intezar's car. It could be seen that when the main party in retreating, they could also be seen retreating. However, when the main party is rushing to stop the car, they could also be seen rushing towards the car. However, they started firing on the car, apparently in an attempt to stop it. It could also be seen that all the officials of ACLC were in plainclothes and their cars/motorcycles were also unmarked. It also appears that they did not introduce themselves as police officials. It appears that there was confusion amongst the police party whether to stop the car or let it go.

Video footage also shows that all ACLC officers fled away from the crime scene immediately after the firing without approaching the vehicle which stopped in an empty plot on the other side of Ittehad after hinting /crossing the median. They did not try to approach the vehicle to check the occupants of the car or try to help or rescue them. (CD of CCTV footage is attached as Annexure-XXVI)



After the examination of the CCTV footage the relative position of police officials involved in the incident before and after the shooting is explained in the following sketches:





## 8. ANALYSIS OF CALL DATA RECORD.

The CDRs of the police party involved in shooting, SSP Muqudas Haider, deceased Intezar, Mr. Ishtiaq, Ms. Madiha Kiyani, Mr. Fahad and Mr. Suleman was obtained and sent to the digital forensic lab of Counter Terrorism Wing, FIA Islamabad. The CDRs were analyzed on I-2 Software and the link charts for the day of incident and for a period of one month before and after the incident were developed. The CDR analysis does not show any contact between the Police party involved in the shooting, SSP Muqudas Haider and Madiha Kiyani. (Link Charts at Annexure-XXVII). Furthermore, call data of involved police officials was checked with the call data of Insp Amir Hameed and Mr. Sohail brother of Insp Amir Hameed and no contact could be established.

## 9. VIDEO STATEMENT OF MADIHA KIYANI

On 1<sup>st</sup> March 2018, a video statement of Madiha Kiyani went viral on Social media, in which she claimed that Intezar's murder was planned and she felt threatened for her life as she recognized one of the key characters of the deadly episode. She told that Mahrukh and Inspector Amir Hameed may be questioned in the case. In the video she seemed visibly nervous and shaken. Mr. Ishtiaq Ahmed could also be seen in the video and the clips were recorded by the lawyer of Mr. Ishtiaq Mr. Asif Khudai on his cell phone.

The JIT called Madiha, Mr. Ishtiaq, Asif Khudai Advocate and Kazim Shah and questioned/interviewed them in detail. It was revealed that Madiha and Kazim Shah (a friend

of Intezar) had met few days before Intezar's death. They met many times after Intezar's death and were taking drugs together. In the early hours of 01.03.2013, Kazim Shah picked her from her home and they had drugs. They went to the house of Mr. Ishtiaq and discussed with him what they thought were some revelations about the case. Mr. Ishtiaq called his lawyer and they attempted to take her to some news channel to get her interviewed, failing which they went to the house of Mr. Asif Khudai Advocate. The clips of Madiha were recorded in the house of Mr. Asif Khudai Advocate. The JIT found this conduct of Mr. Asif Khudai Advocate highly inappropriate. The legal course should have been to present her to the Investigation officer, JIT or a judicial magistrate to get her statement recorded. Ms. Madiha Kiyani retracted from her video statement and told JIT that Kazim Shah had drugged her and she made this statement under the influence of drugs and out of his fear. As far as the issue of joining of investigation of Mr. Sohail Hameed and Inspector Amir Hameed is concerned, this aspect has already been covered by the JIT.

#### 10. FINDINGS.

- i. On 13.01.2018 Intezar's car was stopped in front of Castle lights in Bukhari Commercial Area near Khayaban-e-Ittehad by the following 8 officials of Anti Car Lifting Cell (ACLC):
  - a. Inspector Tariq Mehmood
  - b. Inspector Azher Ahsan
  - c. Inspector Tariq Raheem
  - d. PC Shahid Hussain
  - e. PC Ghulam Abbass
  - f. PC Fawwad Khan
  - g. PC Muhammad Bilal Rasheed
  - h. PC Muhammad Danyial
- ii. HC Ghulam Abbass, who has been nominated in the FIR, was not present at the place of incident when the firing took place.
- iii. The entire Police Party of ACLC was in plainclothes, contrary to the SOP issued by SSP ACLC in shape of a written deployment order.
- iv. PC Bilal and Daniyal, who were gunmen of SSP ACLC, went to the place of incident to deliver some personal items of SHO Inspector Tariq Mehmood. They were off duty and took part in the operation at their own, without any authorization by SHO ACLC Inspector Tariq Mehmood or SSP ACLC Muqudas Haider.
- v. PC Bilal and PC Daniyal fired on the vehicle, causing death of Intezar.
- vi. Examination of vehicle shows that there are three bullet marks, and two bullet scratch marks on the right/driver side of the vehicle due to ricochet of the bullet from the road. The evidence conclusively suggests that PC Bilal's bullet hit Intezar and killed him.

- vii. Eighteen (18) empties were recovered from the crime scene. All eight weapons of ACLC officers were sent for forensic examination, along-with the recovered eighteen (18) empties. Forensic examination shows that only two weapons were used in the incident. Twelve (12) empties were fired from PC Bilal's weapon and six (6) were fired from PC Muhammad Daniyal's weapon.
- viii. After the incident, the entire police party fled away from the scene of incident. They should have stopped there and tried to evacuate the victim in an attempt to save his life.
- ix. The allegations of any connection or relation between Ms. Madiha Kiyani, who was present with Intezar at the time of firing incident, and SSP Muqudas Haider were found to be incorrect and baseless.
- x. So far no involvement of any friend of Intezar namely Suleman and Saad in the firing incident was found.
- xi. During the course of JIT proceedings, involvement or nexus of Dr. Murad Wakeel in the killing of Intezar was found to be incorrect and baseless.
- xii. So far the JIT could not find any evidence of involvement of Mah Rukh, Mr. Sohail or Inspector Amir Hameed in the shooting incident of Intezar. No technical or investigative link could be established between Mr. Sohail, inspector Amir and the ACLC team involved in the incident. The immigration FIA immigration record shows that Mr. Sohail departed from Pakistan on 5<sup>th</sup> May 2017 and Mahrukh departed from Pakistan on 18<sup>th</sup> August 2017.
- xiii. JIT is of the opinion that the incident occurred due to stopping of Intezar's car in a highly unprofessional manner by ACLC team in plainclothes, and unmarked vehicles without any police identification.
- xiv. So far the JIT could not find any motive behind this killing. It appears cold-blooded rash and negligent killing by police officials in plainclothes.
- xv. The JIT noted that there is no general Standing Operating Procedure (SOP) in black and white to guide police officials for stop and search, delineating the role of plain clothes and uniformed personnel.
- xvi. The viral video of Madiha Kiyani was recorded at the residence of Asif Khudai Advocate. Kazim Shah made Madiha record this statement under influence of drugs. Later on Madiha retracted from her statement.

## 11. RECOMMENDATIONS.

The Joint Interrogation Team (JIT) is of the opinion that the involved 8 police officials should be challaned for their criminal act of merciless and cold-blooded killing of Intezar in a rash and negligent act, and not rescuing him after the firing incident. Name of HC/Ghulam Abbas should be placed in Column No. 2 of the charge sheet with blue ink as he was not present at the place of incident when firing took place. The JIT also recommends strict departmental action against the involved Police officials. Inspector General of Police

may look into the role of supervisory officers, including SSP ACLC Muqudas Haider and DSP ACLC for their failure to implement the Deployment Order issued for checking of vehicles in DHA area.

The JIT further recommends Sindh Police to draft and issue a comprehensive Standard Operating Procedure (SOP) for stop and search operations so that such unfortunate incidents could be avoided in future.
