At the very ou Barrister Zameer Ghumro, Advocate General Sindh, on instructions from the Chief Minister-Sindh, states that the Government is intending to revisit the National Accountability Ordinance, 1999, Sindh Repeal Bill 2017, therefore, matter be adjourned. However, he has neither filed any categorical statement in this regard nor in a position to state that by virtue of said subsequent legislation the aforesaid Sindh Repeal Bill is going to be rescinded. Be that as it may, at his request the matter is adjourned to 09.10.2017 at 12 noon. However, in continuation of our earlier orders dated 16.8.2017 and 22.8.2017 NAB shall do the needful while the Advocate General and Chief Secretary, Sindh shall ensure that no hindrance is created in this respect. On the next date the Advocate General in line of our above referred orders shall place on record minutes of deliberations of Members of Provincial Assembly prior to the passage of the bill and confirmation whether the bill was placed before any sub-committee for deliberations before presentation in the Assembly coupled with the dissenting note of the Governor of Sindh on the said Bill failing which we will be constrained to pass appropriate orders for taking action against the delinquent.

Office is directed to issue notice in terms of Order XXVIIA CPC to the Advocate General and the Attorney General for Pakistan in CP NO.D-5904 of 2017 for the aforesaid date and time.
