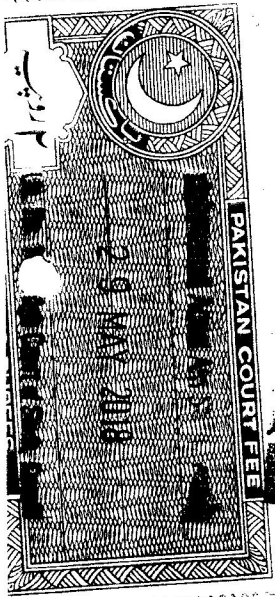

In pursuance of our last order dated 23.05.2018, the Deputy Director (PCRDP) Social Welfare Department, Government of Sindh has filed compliance report to show that on 23.05.2018 notice of 3rd meeting was circulated and meeting was convened yesterday. The Summary has been moved to the Chief Minister Sindh on 24th May, 2018 for release of requisite funds to the authority. Learned Additional Advocate General (Sindh) submits that Chief Secretary is pursuing the Summary for its approval. The Director Social Welfare has also shown us a draft of public notice for the private establishments, which has been sent to the information department, Government of Sindh to create awareness in the private establishment so that they may make some provisions for the employment of differently able persons in their establishments. We have noted that a letter has been written to the Director (Advertisement) Information Department, Government of Sindh, Karachi with the request to arrange publication in the three leading newspapers in Sindhi, English and Urdu. At this juncture, we would like to add that in the present era it is also necessary that this notice should be ~~broad cast~~ broadcast through electronic media including PTV and other private news and entertainment channels



immediately. We also issue directions to the Social Welfare Departments Sindh to release one more public notice for the general awareness of the differently able persons including the process of their registration with the address of the nearest office where they can go and file their applications for registration. This Notice shall also be circulated through PID for print and electronic media. Adjourned to 28.5.2018. Since the summary has been moved to the Chief Minister Sindh, we expect that funds will be approved for the authority on or before 28.05.2018. The progress report should be submitted on the next date.
