Witnesses posted at Shah Lateef town Malir Karachi (1) SHO/SIP Amanullah Marwat (2) HC Sadaqat Ali Shah 15448 (3) PC Raja Shamim 27970 (4) HC Mohsin Abbas 17701, (5) ASI Gada Hussain statements under Section 161 Cr.P.C. has been recorded. On the information of the ASI Saleem Ahmed Duty officer SHO with reference to Report No. 28 @ 1520 reached at the place of occurrence alongwith HC Mumtaaz Ali 15730 and PC Zafar Iqbal 11634 and took the dead bodies of the deceased persons namely (1) Muhamamd Ishaq son of Karim Bux (2) name and address not known (3) Nazar Jan son of Atam Jan (4) Name and Address not known were sent through Chippa and Edhi Ambulance to the Jinnah Hospital. At Jinnah hospital proceedings under Section 174 Cr.P.C. of all the four bodies was conducted in presence of witnesses namely HC Gulzar Ahmed 19300, HC Mumtaaz Ali 15730 and the copies of the proceedings were handed over to the MLO Dr. Abdul Ghaffar. MLO did the postmortem with reference to MP No. 22/2018 to 25/2015 and declared the reason of the deceased persons as death 7 from the arms fires and also took photographs of the dead bodies. Due to non availability of the relatives/heirs the dead bodies of the victims were kept in the mortuary at Chippa Sard Khana. On return the proceedings were entered vide report No. 48 at 0010 hours dated 14.01.2018 and the proceedings documents alongwith four bundle particles and samples duly sealed were handed over to IO Inspector Nasrullah. Who recorded statements under section 161 Cr.P.C. of the ASI Saleem Ahmed and witnesses HC Gulzar Ahmed and HC Mumtaaz Ali and Guard Commander HC Muhammad Ali. The exploded hand grenade that was recovered from place of incident, was sealed by SI Jan Muhammad Mangi of BDU and alongwith Clearance Certificate was handed over to Duty officer SI Qurban Ali Totani, Statement under Section 161 Cr.P.C. of the Duty officer was recorded. During investigation, the encounter person / victim no. 4 who was killed on 17.01.2018, who was identified as Naseemullah @ Naqeeullah son of Muhmmad Khan caste Mehsood, by his uncle Mamo Muhamamd Hussain son of Khizan Gul resident of Hub Chowki Balochistan and permanent resident of Bahdurkhel Taluka Makyan district South Waziristan Agency Mobile No. 0345-2786950 who came alongwith Saif ur Rehman son of Mehar Dil Khan (cousin of the deceased) came before the Ist IO Inspector Nasrullah, who were given letter for Chippa Cold House for the funeral of the dead body,



statement of the above said tow persons was recorded and transitory certificate for carrying the dead body to the native place was issued.

On the order No. AIGP/OPS/2345-51/2018 dated 18.01.2018 of the IG the Inquiry committee consisting of Addl IGP CTD Sindh Karachi (PS) posted at CTD (Chairman) (2) DIGP Sultan Ali Khawaja (PSP) East Zone Karachi (Member) (3) DIGP Azad Khan (PSP) South Zone Karachi (Member) submitted the detail report, according to which the so called police encounter was declared as fake and the cases lodged against the victims were terms as false cases. Copy of the report is enclosed.

Meanwhile, the investigation of FIR No. 17/2018 and other connected cases was transferred SSP Investigation II East Abid Hussain Qaim Khani Investigating officer with reference to Order No. DIGP/EAST/RDR/261/2018 dated 21.01.2018 and on the same day DIG East Zone in assistance of the investigation vide Order No. DIGP East RDR-262/2018 constituted an investigation team consisting of SSP Investigation I East Zone, SSP investigation 3rd East Zone and SSP CTD operation Sindh. The complainant of the above FIRs and witnesses, who by the time had gone underground. Notices were pasted at the Houses of SSP Rao Anwar, SIP Shoaib Shaikh, SIP Amanullah Marwat and others. The motorcycle which was shown to be recovered from the deceased persons i.e. Motorcycle No KHN-5858 which was kept at Police Station Mobina Town on 02.12.2016 under seizure, the copy of the seizure registered was obtained on 22.01.2018 alongwith 5x official SMG alongwith Magazine and bullets as per memo alongwith Kot Register was taken into police custody and was sealed. After which the same were submitted for FSL examination. On 23.01.2018 Hafiz Abdul Wahid son of Khair Muhammad resident of basti Long Wali Muhamamd Lang Gardan Hyderpur Taluka Ahmedpur Shirkia mobile No. 0300-4093763, who identified the victim no. 2 as real nephew was given letter for the Chippa Cold House for obtaining dead body and also transitory certificate was given so that the dead body could be taken to the native place for funeral ceremonies. His statement was recorded. On receipt of the postmortem report the bundles of particles and blood polluted soil were sent for chemical examination. The FSL reports and chemical report of the case property as detailed above and BDU Inspection report were received which are enclosed. In FIR No. 17/18 under Section 353/324/34 PPC R/W 7 ATA the forensic report of the place of incident was received with reference to AIG/FD/OR/F-A/442/A Dated 22.01.2018. After the examination the FSL authorities have stated in their report which is as under:

The Examination of the crime scene has revealed that:

- (1) Boundary wall: Impacts on the outside of boundary wall, no any impact found on the inner side of boundary wall. One entrance on the frame of main door.
- (2) Room No. 1 (Left Side): Impacts on inner side of back and right side wall.



- (3) Room No. 2 (Middle): Impacts on inner side of back and right side wall holes of projectile found on the window of back side wall. (Fired from inner side) and holes on the door (Fired from outside).
- (4) Room No. 3. (Right Side): No any evidence of projectile trajectory found in the room.
- (5) Direction of Fire: Direction of fire was from front side of house towards back side of the house.

The Recovered 26x fired bullets of SMG which were recovered from the outside of the house, these were found from same place by the inspection team during the examination, and these were examined/matched with the police Party official SMGs and the report was received vide reference No. AIG/FD/OR/FA 544-A Dated 26.01.2018. The examination report was received under (Dissimilar), which establishes that on the day of incident the complainant of the case SHO has not taken the fired bullet empties fired from the official SMG and thereafter the fired bullet cases were kept there intentionally and as such has attempted to hide the real facts, to temper with the evidence and to hinder in obtaining of justice. The cases lodged against the encountered persons in the above case has been disposed off in Class B after the investigation and approval of the highups.

In such circumstances FIR No. 142/2018 under Section 26 of Sindh arms Act, R/W 3 / 4 of Exp Act R/W 7ATA was lodged at police station Shah Lateef Town Karachi against Case may be lodged against accused persons namely (1) Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan (2) Ex SIP Muhammad Anar son of Umer Hayat Tarar (3) Ex HC Faisal Mehmood son of Muhammad Naib (4) Ex PC Shamim Mukhtiyar son of Raja Mukhtiyar Hussain (5) Ex SIP Amanullah Marwat son of Saeedullah Khan (6) Ex ASI Gada Husasin son of Faiz Muhammad (7) Ex HC Sadaqat Ali Shah son of Ghulam Hussain Hamdani (8) Ex HC Mohsin Abbas son of Noor Zaman (9) Ex PC Rana Riaz Ahmed son of Fayyaz Ahmed (10) Ex SIP Shaikh Shoaib @ Shoaib Shootar son of Shaikh Asghar Ali (11) Ex ASI Khair Muhamamd son of Jamal Din (12) Ex SDPO Malir City Qamar Ahmed Shaikh.

On 23.01.2018 on the written statement of the complainant of the case Muhammad Khan son of Mama Case FIR No. 40/2018 was lodged which is reproduced as under:

To the SHO Police Station Sachal Karachi.

Respected sir,

It is submitted that I Muhammad Khan son of Mama Asal resident of South Waziristan presently residing at Karachi. My son Naqeebullah Masood who came at Karachi for work/labour He was 24 years old and on 03.01.2018 at about 0300 O'Clock in noon 8/9 officials of SSP Malir Rao Anwar dressed in civil clothes picked him from Gul Sher Agha Hotel Chappal garden Abul Hassan Isphani road Karachi alongwith Hazarat Ali son of Shakir Qaseed and Muhammad Qasim son of Daad, who



were left on 06.01.2018 at about 10.00 p.m. in night at Super highway Karachi, while, my son was still kept in confinement by Rao Anwar and they switched off the mobile phone of my son. My friends and relatives made search for him. On 17.01.2018 through TV and Newspaper news was published that my son has been killed by Rao Anwar and his associates in Fake Police Encounter on which IG Sindh has constituted an inquiry consisting of Higher officers of Police, who in their findings have found the involvement of the Rao Anwar and his subordinates. Besides the high-ups Sherdab Khan son of Sharbat Khan and Humaiyun son of Muhammad and many more are the witness of the incident. Therefore my claim is against SSP Rao Anwar and his 8/9 subordinates (whose names need to be discovered) who abducted my son Naqeebullah and kept him in illegal detention and killing him in fake police encounter. Case is registered. This incident has spread fear and terror amongst the people, case be lodged and action be taken. Therefore, on the application of the complainant of the case SHO Inspector Shakir Ali registered the above case and the investigation of the case was handed over to the SSP Investigation II East Karachi Mr. Abid Hussain Qaim Khani by the orders of high-ups. On 26.01.2018 IGP vide Order No. 3538-49/AIGP/OPS/III/2018 dated 26.0.2018, under the supervision of Addl IGP Sindh Mr. Aftab Ahmed Pathan PSP, an investigation team was constituted in the above case.

On 26.01.2018 in the above case the eye witnesses and abductees namely Hazrat Ali and Muhammad Qasim recorded their statements under Section 164 Cr.P.C. before the JM IV Malir Judge Mir Sagar Khan Abro and on 31.01.2018 the identification parade of the arrested accused persons namely ASI Allahyar Kaka son of Juma Khan (2) HC Muhamamd Iqbal son of Ahmed Yaar 14694 (3) PCPC Arshad Ali son of Mazhar Ali 5648 was carried out through the eyewitnesses and abductees namely Qasim son of Dawood and Hazrat Ali son of Shakir before the JM IV Malir Karachi. In the identification parade the witnesses identified all the three accused persons, the copy of the identification parade is enclosed. CRO, Photo Finger was conducted of the accused persons. On 01.02.2018 further police remand of the arrested accused persons was obtained from the competent court till 06.02.2018. During investigation the Raiding parties for the arrest of the accused persons supplied their reports which are enclosed.

During investigation of the above case the high-ups vide order dated NO/Addl.IGP/Sindh/438-49/2018 dated 22.02.2018 a team of the officers was constituted that consist (1) DSP Jaffer Baloch (2) DSP Mehmood Hussain Raja (3) SIP Shakir Hussain (4) SIP Malik Muhammad Sarfaraz (5) ASI Shahzad (6) PC Imtiaz Hussain 25822 (7) PC Shafiq Ahmed 12855 in order to get criminal record of the deceased persons (1) Muhamamd Sabir son of Muhammad Bux (2) Muhammad Ishaq son of Raheem Bux to the district Bahawalpur. The team after investigation submitted their report to me investigating officer. The report states that Muhamamd Sabir son of Muhammad Bux was picked up by the government officials on 09.11.2016 due to some unknown reasons from Multan Shujaabad. While

regarding the other deceased person namely Muhamamd Ishaq son of Raheem Bux he was picked on 10.11.2016 from basti Long Garwat post office Hyderpur Taluka Ahmedpur Sharqi District Bahawalpur by some 25/30 police officials who were either in civil dresses or in police uniforms. While the criminal records of both the deceased persons are silent nor there was any missing report available in any police station of court. Detailed report is enclosed.

While according to the report of DPO Bahawalpur the criminal record of the deceased persons is also silent. Report is enclosed.

During investigation on 11.02.2018 accused person 1. PC Ghulam Nazuk 2. PC Abdul Ali son of Allah Bachaio 3. PC Shafiq Ahmed son of Shafi Muhammad were formally arrested and police custody remand of all the three accused person was obtained from the Hon'ble Court of Administrative Judge ATC Court after which they were interrogated. Photo Finger and CRO record was compiled of the accused persons. During investigation upon the pointation of the place of incident by the arrested accused persons namely 1. Ex PC Ghulam Nazuk 2. Ex PC Abdul Ali son of Allah Bachayio 3. Ex PC Shafiq Ahmed son of Shafi Muhammad, the Memo of place of incident was prepared and is enclosed. Police custody remand of all the three accused person was obtained from the Hon'ble Court of Administrative Judge ATC Court and the accused persons were interrogated. Photo Finger and CRO record was compiled of the accused persons. During investigation upon the pointation of the place of incident by the arrested accused persons namely 1. Ex PC Ghulam Nazuk 2. Ex PC Abdul Ali son of Allah Bachayio 3. Ex PC Shafiq Ahmed son of Shafi Muhammad, the Memo of place of incident (Abduction) was prepared and is enclosed.

On 19.02.2018 the said three arrested accused persons were sent to the jail under Judicial Custody by the orders of competent court. During investigation on 20.02.2018, DSP Qamar Ahmed Shaikh SDPO Malir City was formally arrested in the above case. On 21.02.2018, police custody remand of the accused was obtained till 27.02.2018 from the Administrative Judge ATC Court at Sindh high Courts. During investigation FSL examination was carried out of the arms and ammunition recovered from the place of incident and the report is enclosed. During investigation statements of the heirs of the deceased person were recorded which are enclosed. The teams constituted by the high-ups upon the approval from the Home Department are conducted raid in different areas in different cities for the arrest of the accused persons.

In view of the evidence collected Ex DSP Qamar Ahmed has also made entries regarding the fake encounters. Entries and log books with reference to the case has been included in the case. Interview contradictions, are available on record. During investigation it has been established that DSP Qamar Ahmed was present at the time of incident and was involved in destroying evidences and entries and in facilitation of the crime. Ex SSP Rao Anwar, Statement of the witnesses under Section 161 Cr.P.C. CDR location and the interviews of Rao Anwar received from the Media in form of CDS and the

investigation carried uptill now clearly established that SSP Rao Anwar was the principle accused in the fake police encounter, he is proved to be the head of the of the team who were involved in the crime from abduction of the deceased Naqeebullah, Muhammad Ishaq, Muhammad Sabir and Nazar Jan till they were pronounced as fake terrorists.

In the above case after examination by the chemical examiner 3x Carpets and clothes of the deceased persons has been sent to forensic lab Lahore for examination of DNA Test. On receipt of the report the previous investigating officer SSP Investigation II East Abid Hussain Qaim Khani had enclosed the same with the case. According to the report the one out of the Carpets obtained from the place of incident, has evidently blood of two deceased persons, while the carpet in the other room has proved to have blood as has proven through DNA, which proves that, firstly all those four deceased persons were killed in same room in fake police encounter and then out of those four, dead bodies of two were shifted to other room. While, according memo of place of incident in FIR No. 17/2018 to 21/2018 shows that two dead bodies were found on one carpet in one room and two dead bodies were found on the other carpet in other room. In this regard two different DNA Test were sent to Experts Laboratory Lahore for examination and the report of which after examination has been received, and according to which the DNA of deceased Nazar Jan son of Atam Jan were sent for examination and were found on both the carpets. While, perusing the other report it has been established that except Deceased Nazar Jan all the other holes were not possible to be examined for FSL. While, FSL examination of the clothes of the deceased Nazar Jan it has revealed that he has been killed by firing from a distance of 1 to 5 feet. Both the reports verify that FIR No. 17/2018 to 21/2018 are fake. The map was prepared through Tapedar of the place of incident where the deceased were shown to be encountered in fake police encounter in FIR No. 17/18 under Section 353/324/34, PPC, R/W 3/4 of Exp Act R/W 7ATA of Police Station Shah Lateef Town, which is enclosed herewith. The CD of video recording statements of the eye witnesses of the case has been sent for forensic examination to FIR and for others CDS of Geo News, ARY news, Duniya News Dawn News letter has been sent to chairman PEMRA.

On 20.03.2018 the Higher Officers appeared before the Hon'ble Supreme court of Pakistan in respect of Suo Moto case HRC # 1949-K/2018. During hearing of the case the non arrested accused person in the above case namely Ex SSP Anwar Ahmed surrendered before the Hon'ble Supreme Court. In the circumstances the Hon'ble Supreme Court Ordered for arrested of Ex SSP Anwar Ahmed, as such in compliance to the Hon'ble Court Order the previous Investigating Officer of the above case SSP Investigation II East Karachi Mr. Abid Hussain Qaim Khani officially arrested the accused i.e. Ex SSP Anwar as per memo. While, during the hearing of the case the Hon'ble Supreme Court further ordered for constitution of JIT in the above case as well as in the connected cases. Which consists of following members.

Thereafter, the arrested accused Ex SSP Anwar Ahmed was brought to Karachi and was presented before the Anti Terrorism Court NO. 2 Clifton Karachi and physical police custody remand of the accused was obtained for 30 days. Meanwhile, JIT senior Member Addl IG Sindh Aftab Ahmed vide Order No. Addl. IG/Sindh/887-907/2018 dated 22.03.2018, entrusted the further investigation of the above FIR as well as FIR No. 142/2018 under Section 26 Arms Act and ¾ of Explosive Act R/W 7ATA of Police Staiton Shah Lateef Town Malir Karachi to me SSP the undersigned. While vide Order of ADDL IG No. Addl. IGP/Sindh/908-917/2018 dated 22.03.2018 the investigation of FIR No. 18/2018 to 21/2018 under Section 24 Arms Act of Police Station Shah Lateef Town Malir Karachi were also entrusted to me SSP the undersigned.

I, the undersigned SSP Dr. Rizwan Ahmed Khan got busy into the investigation of the above case and examined the case in detail and it came into my knowledge that FIR No. 17/2018 under Section 353/324/34 PPC R/W 7ATA of Police Station Shah Lateef town Karachi and connected case 18-19-20-21/2018, which were registered by the complainant i.e. the Ex SHO and accused in the above case SI Amanullah Khan Marwat on 13.01.2018 after the police encounter at Police Station Shah Lateef Town Karachi, the details of which has been mentioned in the paragraphs above. The mentioned FIR Nos 17 to 21/2018 has been disposed off upon conclusion of the investigation by the approval of high-ups in final report under Class "B" and in this regard FRT "B" Class has already been submitted that the ATC Court No. 2 Clifton Karachi, which is under trial of the court. While, in the above case the final challan through Chare Sheet No. 77/2018 dated 13.03.2018 has already been submitted. While FIR No. 142/2018 is under investigation in which the accused ex SSP Malir Anwar Ahmed is under police custody till 21 April. While, the SDPO Qamar Ahmed Shaikh is on judicial custody remand till 21 April.

I SSP Dr. Rizwan Ahmed Khan have gone through page by page the originals of the FIRs in detail. And all the evidences after verification were extended. Further statement of previous investigating Officer SSP Abid Hussain Qaim Khani posted at Investigation II East Karachi was recorded under section 161 Cr.P.C. The brought all the facts and circumstances to the Members of JIT Committee. Who held number of meetings at Malir Cantt and CPO Karachi, the details of which is as follows:-

JIT on several occasions in their meetings detailed as above has interrogated the Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan in the above two cases and in presence of JIT Members the above accused has got examined the place of incident after correct pointation of the place of incident I SSP on 31.03.2018 1750 hours prepared memo of pointation of place of incident. JIT members in order to arrest the non arrested accused persons has constituted different teams under the SHO's of different police station and they were being given directions, who tried their best to arrest them but due to the Media advertisement the accused persons have prior knowledge of the cases lodged against them and under the fear of arrest they have absconded themselves, but the search is still continued. Inthis regard I SSP and Members of JIT Committee i.e. higher officers called the eye witnesses of the case namely Muhammad Qasim son of Dawood and Hazrat Ali son of Shakir and heard their statements in which both the witnesses verified and supported their earlier statements recorded under Section 161 Cr.P.C. and Identification parade. While, the other witnesses of the case were also called by me SSP and JIT Members, who also verified and supported their statements. Members JIT Committee and I SSP, the investigating officer of the case through every possible means and resources have perused the said two cases and examined the same. While, after obtaining NoC from the Hon'ble Court No. 2 ATC Clifton Karachi in the above case has interrogated separately the arrested accused persons who are in judicial custody i.e. 1). Ex ASI Allayaar Kaka son of Juma Khan (2) Ex HC Muhamamd ibqal son of Ahmed yaar (3) Ex PC Arshad Ali son of Mazhar Ali (4) Ex PC Ghulam Nazuk son of Ghulam Akbar (5) Ex PC Shafiq Ahmed son of Shafi Muhammad (6) Ex PC Abdul Ali son of Allah Bachaio, inside the Central jail Karachi. Who regarding the allegations leveled against them stated that they had picked Naqeebullah and his friends from Sher Agha Hotel on the directions of Chowki Incharge Akber Mallah and after that they were brought at Abbas Town Chowki and they were unaware of the fact that they will be killed fake police encounter.

Several meetings were held of the JIT Members the details of which has been mentioned above. In few of the meetings the Ex SSP Rao Anwar was interrogated and interrogation statement was compiled

and he was asked to provide evidence in his defence, but the accused during the course of investigation has failed to provide any cogent evidence in his defence.

In this regard JIT Member Officers in view of the statements and verification of the said two eye witnesses namely Muhamamd Qasim son of Dawood and Hazrat Ali and other information has examined Police Chowki New Sabzi Mandi Police Station SITE Super high Way Industrial Area Malir Karachi and Police Chowki Abbas Town police Station Sachal Malir Karachi alongwith the place of abduction in the above case i.e. Quetta Sher Agha Hotel adjacent to Chappel Garden.

The arrested accused in the above cases Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan during interrogation has failed to provide any evidence to prove that he is not involved till now and during interrogation the accused is using tactics to avoid the situation and is reluctant to state the real facts. While from the examination of the place of incident and pointation of the place of incident proves the presence of Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan at the place of incident. While from the investigation carried up till now it is established that the Case FIR No. 17/2018 to 21/2018 of police Station Shah Lateef Town were lodged falsely and under the same the deceased persons were killed by pronouncing them as terrorist in fake police encounter. Which has already came on record in the above case and clearly reflects the bad act of the accused persons. In this regard different teams have been constituted and raid are being conducted to arrest the absconder accused persons but till now could not get any success. The murder weapon used in the above case is still not recovered. There is strong apprehension that the same shall be recovered after the arrest of the absconding accused persons so as further discoveries and other players of the offence shall be come on screen.

While Ex SIP Muhammad Yaseen son of Ahmed Yar (2) Ex ASI Supurd Hussain son of Ghulam Hussain (3) Ex HC Khizar Hayat son of Noor Muhammad who are the accused persons have stated that they alongwith their associates brought Naqeebullah on directions of ASI Akbar Mallah at Sabzi Mandi Chowki and they were unaware that he will be killed in fake police encounter.

During investigation vide letter No. Addl/IGP/Sindh/1003-10/2018 dated 09.04.2018, which was written by JIT Senior Member for conducting Geo Fencing and CDR report was already received at DIGP East office from where it was received DIGP west office and from there it was obtained for preparing Memo. During investigation I SSP, carefully studied and perused the digital evidences received by me from the previous Investigating officer and in the light of the same examined the report of Geo Fencing so that the movement of the accused persons, mobile phone Activity and Tower location prior to the occurrence and after the occurrence can be decided.

During investigation I SSP carefully gone through and studied the Digital evidences obtained from previous investigating officer and in the light of the same get conducted Geo Fencing so that the movement of the nominated accused persons and their role before the occurrence and after the occurrence can be clarified that which accused played which role and how the offence of the above

FIR took place. While perusing the CDR record of the Ex ASI Akbar Malah it has came on record that the first act did by accused Akbar Mallah after picking the deceased Naseem @ Naqeebullah son of Muhammad Khan and his friends from Sher Agha Hotel, was to call on Cell Phone No. 0300-5915901 which is in the name of Malik Haji Muhammad, however, the same shall be confirmed on the arrest of the ASI Akbar Mallah.

Meanwhile, with the help of Geo Fencing and Special Spy one suspected accused PC Shakeel 34761 was arrested 12.04.2018, whose presence at the place of incident is proved through Digital evidences. After arrest police custody remand of the accused was obtained, so that evidences could be collected against the accused and that he could be properly interrogated in order to reach to the motives of the occurrence as well as to the crime weapon. During interrogation the accused disclosed to the JIT with regard to his presence that he went at the crime scene to meet the Ex ASI Gada Husasin as he was told by the HC Tahir posted at Razzaqabad Training Centre Karachi that file of land is missing and missing report needs to be registered, for which he was called by the Ex ASI Gada Hussain at the place of incident by saying that he will manage to lodge the missing report. While the HC Tahir Hussain in his statement obtained under Section 161 Cr.P.C. has denied the statement of the accused. The record obtained with regard to the posting it is clearly established against the arrested accused PC Shakeel that he has been posted with the absconding accused Ex SIP Anar Khan and Ex ASI Ali Akbar Mallah and has been performing his duties as an active player in their team. However, the statement of the Head Constable Tahir is against the statement recorded by the accused. In view of the these evidences the accused has failed to bring satisfactory reason of his presence at the place of incident which has been proved from the Geo Fencing and CDR record.

That accused PC Shakeel Feroze on 12 January 2018 at 04.34 hours had telephoned Ex SHO/SIP Amanullah Marwat, while on the same day at about 0640 hours the Ex ASI Gada Hussain had called on accused PC Shakeel phone. Beside this it has been found that all these three accused persons were present at the place of incident(murder) on 12.01.2018. Further examination and study it has revealed that accused SIP Anar Khan was present at the place of incident on 13.01.2018 at 0334 hours, ASI Gada Hussain on 1118 hours, ex ASI Khair Muhamamd at 0212 hours while Raja Shamim at 0351 hours were present at the place of incident and it has been recorded at Cell Phone Activity on the concerned tower. While accused PC Shakeel Feroze was in contact with ASI Gada Hussain a day before the incident till 18.01.2018 and during this period he has contacted 18 times. While it is also revealed that after the incident the accused PC Shakeel Feroze has on several occasion changed his Sim and Mobile Phone. From the above Digital evidences it is established that the accused persons have played the main role in planning of fake police encounter and completion of the task. Moreover, all these evidence proves that the accused has not informed regarding the offence and has facilitated the team who has conducted the fake police encounter.

The following facts have came on record from the perusal and examination of the above digital evidences, details of which is as under:-

- Accused Ex SSP Rao Anwar presence is found at the place of incident from 0255 hours to 0321 hours. While the perusal and observation of Geo Fencing Data it is also proved that the location of 0300-2023318 i.e. in the use of the accused Ex SSP Rao Anwar is showing at Super High Way near Sabzi Mandi Chowki on 04, 05, 08, 09 and 13 January 2018. (Note the report is extract from Phone Calls Activity)
- Similarly, the location of the Nos. 0331-2101119 and 0336-3080041 under the use of accused Ex SSP Rao Anwar through the Phone Calls Activity is showing that the accused Ex SSP Rao Anwar was present at 0243 hours at the place of incident (Murder).
- While, observing the Cell Phone Activity of the Accused Ex SI Muhamamd Anar Khan it has come up that the accused at 01.55 hours to 0334 hours was present at the place of incident (Murder). This information of Cell Phone Activity has been extracted from the concerned Tower record.
- The observation of Cell Phone Activity of Accused Ex SI Muhammad Shoaib Shaikh @ Shoaib Shooter it is revealed that his presence was found near the place of incident (Murder).
- While the observation of Mobile Phone Activity of accused Ex ASI Gada Hussain it is found that the accused was present at the place of incident(murder) at 1118 hours.
- Similarly the observation of Mobile Phone Activity of accused Ex ASI Khair Muhamamd it is found that the accused was present at the place of incident(murder) at 0212 hours.
- While the ex HC Sadaqat Hussain was also present at the place of incident which is proved from the other factual evidences. However, the same is not came while observing his Mobile Phone Activity. Which shows that at the time of incident the mobile phone in his use was switch off.
- The ex HC Mohsin Abbas was also present at the place of incident which is proved from the other factual evidences. However, the same is not came while observing his Mobile Phone Activity. Which shows that at the time of incident the mobile phone in his use was switch off.
- The ex PC Rana Riaz Mohsin Abbas was also present at the place of incident which is proved from the other factual evidences. However, the same is not came while observing his Mobile Phone Activity. Which shows that at the time of incident the mobile phone in his use was switch off.
- While observing the Geo Fencing report of Mobile No. 0315-2368546 under the use of Ex PC Raja Shamim, the mobile phone is seen active at the place of incident. In this regard the detail report of Geo Fencing and CDR is enclosed.

Ex SSP Rao Anwar Ahmed and his team's different members were in contact from 03.01.2018 to 13.01.2018 and even after that. While during investigation it is revealed that the Ex SSP Rao Anwar Ahmed had contact with PC Jehangir Khanzada @ Guddu Party through Ex DSP Qamar Ahmed Shaikh and with the PC Shakeel Feroz his contact was through SI SHO Amanullah Marwat. That on observing and examination of the Geo Fencing of Accused Ex DSP Qamar Ahmed Shaikh mobile phone it is revealed and proved that Ex ESP Qamar Ahmed Shaikh before the incident and after the incident was in contact with officials and officers involved in the fake police encounter.



While, statement under section 161 Cr.P.C. 164 Cr.P.C. CDR Record and Geo Fencing Record against the absconding accused persons in the above crime (1) Ex ASI Ali Akbar Mallah son of Muhammad Siddiq shows that the Naseemullah @ Naqeebullah son of Muhammad Khan and his friends were abducted and were taken to Abbas town Chowki and then taking them to Sabzi Mandi Chowki where they subjected them to torture and were demanded for money. And also on 13.01.2018 has facilitated the officials in police encounter. This act of the accused person falls under Section 365-A/302/201/202/114/34 PPC.

Moreover, in view of the evidences collected it is proved that DSP Qamar Ahmed had made entries in respect of the fake police encounter, Log Book shows the contradiction in recording of entries, tempring the evidences and entries to facilitate the team, it is also established through CDR and Geo Fencing record that the accused was in contact with team which conducted fake police encounter before the incident and also after the incident.

In view of the above facts and circumstances and evidences the offences against the Ex DSP Qamar Ahmed Shaikh (Arrested) falls under Section 109/201/202/114/ 34 PPC.

While from the memo of examination of place of incident (Memo of examination of Forensic report), Forensic report regarding weapons, Digital evidence, technical reports, CDR locations and Interviews CDs of Ex SSP Rao Anwar received from the media and other circumstantial evidences against the arrested Ex SSP Rao Anwar Ahmed Khan son of Nisar Ahmed Khan and non arrested accused person (1) Ex SIP Anar Khan son of Umer Hayat Rarar (2) Ex HC Faisal Mehmood son of Muhammad Naiz (3) Ex PC Raja Shamim Mukhtiar son of Raja Mukhtiar Hussain (4) Ex SIP Amanullah Marwat son of Saeedullah Khan (5) Ex ASI Gada Hussain Son of Faiz Muhamamd Suragai (6) Ex HC Sadaqat Hussain Shah son of Ghulam Hussain Hamdarni (7) Ex HC Mohsin Baas son of Noor Zaman (8) Ex PC Rana Riaz Ahmed son of Faiz Ahmed Rana (9) Ex SIP Shaikh Muhamamd Shoaib @ Shoaib Shooter son of Shaikh Asghar Ali (10) Ex ASI Khair Muhammad son of Jamaluddin and other accused persons, proves that they have committed extra judicial murder of the deceased persons and pronounced the deceased persons to be the member of Banned Organizations, while there is no criminal record of the deceased persons, through media they have high lighted false stories to cover up there illegal extra judicial encounters, and to destroy the evidences, as well as misusing of authority, under the motive to strengthen their other illegal activities. In view of the above facts and circumstances and evidences the offence committed by the arrested accused Persons Ex SSP Rao Anwar and other absconding accused persons falls under Section A/302/114/109/344/342/201/202/220/34 PPD R/W 7ATA. In the above case after completion of the investigation final challan is hereby submitted before the Hon'ble Court for hearing.

In the above case in connection with the search respect of the absconding accused persons assistance is being obtained from the Print Media and Social Media, as well as of intelligence agencies. In the



above case the absconding accused persons are intentionally hidden in order to escape from their legal arrest, whose search is continued. The name of the absconding accused persons have been mentioned under Section 512 Cr.P.C. There is a strong apprehension that after the arrest of the absconding accused persons the murder weapon as well as further discoveries and motives of the crime shall came on surface. On their arrest further inquiry and investigation shall be conducted and report of the same shall be submitted before this Hon'ble Court through Supplementary charge sheet. Therefore in the circumstances through the report above it is prayed that order be passed in the above case, to compile, in view of the investigation carried out till now, through supplementary Challan charge sheet against the arrested accused persons Ex SSP Rao Anwar and PC 34761 PC Shakeel Feroze and other absconding accused person so that Challan through Charge Sheet under Section 173 Cr.P.C. can be submitted before the Hon'ble Court and the date of hearing can be fixed.
