FACTS OF CASE U/s. 302/324/427/34 R/W 457 PPC.,& 7 ATA:

It is submitted that the brief facts of the case are that; on 08-05-14, the SHO / Inspector Zawar Hussain got noted through phone that; he was informed by the Sub – Inspector Sabir Hussain through his mobile phone No. 0300-2426858 that, "six persons boarded in black colored VIGO vehicle No. CU – 2900 came at the Bungalow No. 30/I, Street No. 30, Khayaban– e – Shamsher, Phase – 5, DHA., Karachi of my brother – in – law Ghulam Mustafa Lashari, they parked their vehicle infront of the gate of Bungalow, out of them, three persons who were equipped with Kalashnikovs, have made firing at the gate of Bungalow by standing outside and then, having entered inside from the way of small door of Bungalow, have made injured to security guard Ali Ghulam Bughti and my nephew named Suleman Mustafa Lashari by making firing from Kalashnikovs," on such information, ASI. Abid Hussain on mobile – II Darakhshan and other mobiles were got departed, now, I, ASI Muhammad Ramzan accompanied with PC / SajidQureshi having taken investigation myself proceed to the place of offence i. e. Bungalow, Charge was handed

over to called ASI. Mazhar Ali, the SIO. / Inspector Muhammad Mubeen was informed through phone, copy of report No. 62 is enclosed, after that, I, ASI. Muhammad Ramzan after proceeding U/s. 174 Cr. P. C. of slain Suleman Mustafa Lashari S/o Sardar Ghulam Mustafa Lashari, aged about 18 years and expired accused PC / Zaheer Rind S/o Abdul Waheed Rind and other completed necessary usual proceedings and after obtaining and recording statement U/s. 154 Cr. P. C. of Mr. Zeeshan Mustafa Lashari S/o Sardar Ghulam Mustafa Lashari have come back, copy of statement U/s. 154 Cr. P. C. is as follows:

Mr. Zeeshan Mustafa Lashari S/o Ghulam Mustafa Lashari, R/o House No. 30/I, Street No. 30, Khayaban- e -Shamsher, Phase - 5, DHA., Karachi having NIC. No. 42306-5207883-9, Phone No. 0321-2151018, on inquiry, stated that; I reside at above address with my family and do private job. Tonight, on 08-05-14 @ 0200 Hrs., I was sitting in balcony of my house while my brother-in-law Rahimuddin S/o Salahuddin, my mother Mrs. IrumNaz and our servant Riyazat Ali alias JojiS/o KaluDilawarwere also sitting in balcony and were talking, my younger brother Suleman Mustafa, aged about 18 years, who is student of A Level and was making preparation

of his morning paper by sitting in the lawn of Bungalow that abruptly one black colored VIGO vehicle No. CU - 2900, in which, six persons were boarded, came and parked infront of our Bungalow and the persons boarded therein alighted there, out of them, three (persons) were equipped with Kalashnikovs, armed men made firing at the gate of our Bungalow and these three entered inside while three persons were standing outside, the name of person out of persons entering inside came to know later as Salman Abro S/o Ghulam SarwarAbro, he and his two un known accomplice recognizing by their faces made injured to our security guard Ali Ghulam Bughti S/o Saajan by making firing and Salman Abro S/o Ghulam SarwarAbro while accosting made firing from Kalashnikov at my younger brother Suleman Mustafa with intention to commit murder, resulting which, my brother became injured severely, I from my licensed pistol and our injured security guard Ali Ghulam Bughti from his licensed Repeater made retaliation firing upon them in our self defence, due to which, Salman Abro and his one guard whose name came to know later as Zaheer Ahmed Rind became injured, I accompanied with my mother took to my injured brother Suleman Mustafa and security guard Ali Ghulam Bughti reached at South City Hospital, my brother had sustained bullets shots injuries at left side at neck and on hip while security guard Ali Ghulam Bughti has sustained bullet shot injury on left leg, my brother Suleman Mustafa succumbed to his injuries in South City Hospital, after that, I took the dead body of my brother

Suleman Mustafa at Jinnah Hospital for post mortem, now, I have come to know that Zaheer Ahmed Rind the guard of Salman Abro has also expired, my brother Suleman Mustafa some days prior had told me that Salman Abro had crossed his car at Sea view in wrong manner, uponwhich, harsh words were exchanged with him, now, I depose my statement that my complaint is against Salman Abro S/o Ghulam SarwarAbro and Zaheer Ahmed Rind S/o Abdul Waheed Rind and his other four un known accomplices recognizing by their faces, very daringly to cause loss by making firing at our Bungalow, to kill my brother Suleman Mustafa by making firing from fire arms with intention to kill over the personal grudge and to make injured to our security guard Ali Ghulam Bughti by making firing, after the said occurrence, the locality people and we are afraid, action may be taken. Heard the statement, which is correct. ASI Muhammad Ramzan on returning at PS., has registered the said case on obtained statement U/s. 154 Cr. P. C., all documents of proceeding U/s. 174 Cr. P. C. of slain Suleman Mustafa Lashari and proceeding U/s. 174 Cr. P. C. of accused PC / Zaheer Ahmed Rind (expired), memos of dead body, cause of death and other all documents, wearing clothes, memo regarding seizure prepared by ASI Abid Hussain, one coin, which was found from the body of slain Suleman Mustafa Lashari during post mortem duly sealed up by the Dr. MLO of Jinnah Hospital, Karachi and other case property of slain Suleman Mustafa Lashari and accused PC / Zaheer Ahmed Rind were handed over, I, SIO. / Inspector myself took the investigation, I, SIO / Inspector while initiating the investigation, perused the copy of FIR and all relevant documents. On 08-05-14, I the SIO / Inspector on the information of duty officer had rushed at the place of offence and inspected of place of offence on the pointation of eye witness Rahimuddin in presence of ASI. Malik Muhammad Riaz, during inspection, 26 empties of SMG, 8 empties of 9mm pistol and four jacket cover bullet SMG and two pellets of SMG, two empties of 12 bore Repeater from inside the Bungalow and from outside street No. 30 were taken into police possession and were sealed up separately, clotted blood on tiles of various places of car porch, clotted blood lying on the ground between stairs going to upper floor from the internal main door of bungalow were made wet through cotton, put in plastic shopper and blood stained grass planted in the lawn and (blood stained) earth were put separately in plastic shopper, blood stained cotton and blood stained grass and earth were put in white cloth bag and were sealed up, and the blood of expired accused PC / Zaheer Ahmed Rind was taken into police possession and sealed up as per memo, memo regarding inspection of place of offence and seizure and photograph of place of offence and sketch of place of offence are enclosed herewith. After that, on 08-05-14, the main accused nominated in the said case named 1) Salman Abro S/o Ghulam SarwarAbro and other co - accused persons namely: 2) PC / 147 Magbool Ahmed Brohi S/o Niaz Ahmed, 3) PC / 156 Imran Ali S/o Muhammad Boota, 4) PC / 35 YaseenJamali S/o Khuda Bakhsh Jamali, 5) PC / Driver Muhammad Rashid S/o Muhammad Rafiq were arrested in the said case, at the time of arrest, From accused PC Maqbool Ahmed Brohi, one official SMG, number 55103 is inscribed on cocking handle at the right side whereof while number 55103 is inscribed on body cover at left side and number 3755103 is inscribed on body at left side of SMG alongwith magazine loaded with 18 live rounds without butt having black sling duly sealed up as per memo was recovered while from main accused Salman Abro S/o Ghulam SarwarAbro, SMG under usage at the time of occurrence, number 73658 is inscribed on cocking handle at right side whereof and number 73658 is inscribed on cover towards left side and number 3773658 is inscribed on the body at left side of SMG and SMG is without butt having black sling hook having loaded magazine, uponwhich, black tape is wrapped having magazine loaded with 08 live rounds while another magazine loaded with 30 live rounds and vehicle No. CU - 2900 VIGO black colored were recovered as per memo, memo regarding arrest of accused persons, recovery, seizure and physical search are enclosed as per memos. On 08-05-14, case complainant produced his licensed 9mm pistol and 12 bore duly licensed Repeater under usage of injured security guard Ali Ghulam Bughti as per memo, from which, case complainant Zeeshan Mustafa Lashari and guard Ali Ghulam Bughti had made retaliation firing upon accused persons respectively, which were taken by me the SIO into police possession and were sealed up separately, memo regarding seizure of pistol and Repeater and photocopies of licenses are enclosed herewith, after that, the statements of case complainant Zeeshan Mustafa Lashari, eye witnesses and other witnesses U/s. 161 Cr. P. C. were recorded, original statements in detail are enclosed herewith, during investigation, on 09-05-14, police custody remand of above mentioned accused persons arrested in the said case was obtained from the ATC Court No. III, Karachi till 16-05-14, remand report is enclosed herewith, after that, application was submitted to Area Magistrate in order to conduct identification parade of accused persons arrested in the said case from the case complainant and eye witnesses, so, the Honorable Court fixed the date of proceeding for identification parade on 10 - 05 - 14, copy of application is enclosed herewith, after that, case property as per memos and vehicle No. CU - 2900 were deposited to the Office of FSL and after receiving the same, the PM reports of slain Suleman Mustafa Lashari and expired accused PC / Zaheer Ahmed Rind were deposited at the Office of Chemical Examiner, receiving letters and receiving reports of FSL and report of Chemical Examiner are enclosed herewith, it was found from the perusal of receiving report of FSL that the pellet which was found from the body of slain Suleman Mustafa Lashari at the time of post mortem is of SMG. On 09-05-14, the statements U/s. 161 Cr. P. C. of Mst. IrumNaz wife of Sardar Ghulam Mustafa Lashari and others witnesses were recorded, original statements of witnesses in detail are enclosed herewith, after that, notice U/s. 160 Cr. P.

C. was issued to case complainant regarding identification parade of accused persons, uponwhich, the case complainant executed in writing that there is SOYAM of his slain brother Suleman Mustafa Lashari on 10-05-14, many people are coming from Karachi City and from Interior Sindh for participation, due to which, he is unable to appear before the Honorable Court, copy of notice is enclosed herewith. On 10-05-14, application was submitted again before the Honorable Area Magistrate for re-fixation of date for identification parade of accused persons, uponwhich, the Honorable Court fixed the date on 12-05-14 for identification parade of accused persons, copy of application is enclosed, after that, the statement U/s. 161 Cr. P. C. of injured security guard Ali Ghulam Bughti S/o Saajan was recorded, which is enclosed, during investigation, on 11-05-14, notices U/s. 160 Cr. P. C. were issued to case complainant Zeeshan Mustafa Lashari and eye witnesses namely: Mst. IrumNaz wife of Sardar Ghulam Mustafa Lashari, Mr. Rahimuddin S/o Salahuddin, Mr. Riazat Ali alias Joji S/o KaluDilawar for identification of accused persons and information notices were served to the accused persons arrested in the said case namely: PC / YaseenJamali S/o Khuda Bakhsh Jamali, PC / Muhammad Rashid S/o Muhammad Rafiq, PC / Imran Ali S/o Muhammad Boota, PC / Maqbool Ahmed S/o Niaz Muhammad, copies of notices are enclosed herewith while the main accused named Salman Abro S/o Ghulam SarwarAbro who was under treatment in Ziauddin Hospital, Clifton, information notice could not serve due to operation whereof on 12-05-14, during investigation, on 12-05-14, accused persons arrested in the said case namely: PC / YaseenJamali S/o Khuda Bakhsh Jamali, PC / Muhammad Rashid S/o Muhammad Rafiq, PC / Imran Ali S/o Muhammad Boota, PC / Maqbool Ahmed S/o Niaz Muhammad were produced before the Honorable Court for the proceeding of identification parade, the Honorable Court called to the eye witnesses one by one in the court room and identification parade was conducted in presence of dummies, case complainant and eye witnesses have identified perfectly to the above said accused persons, after completing the proceeding of identification, verified copies of proceeding of identification parade were obtained from the Honorable Court through application in writing, it was found from the perusal whereof that the case complainant and eye witnesses have identified perfectly to the above said accused persons, verified copies are enclosed herewith, during investigation, sketch of place of offence was got made by scale from the Tapedar and it has been enclosed, during investigation, on 14-05-14, whereas, the identification parade of main accused in the said case named Salman Abro S/o Ghulam SarwarAbro, who was under treatment in Ziauddin Hospital, Sheerin Jinnah Colony, was required to get conducted from the case complainant and eye witnesses, so, application for fixation of identification parade to be conducted before the Magistate was submitted to the Honorable Court of DJ., South, Karachi, Magistrate, uponwhich, the DJ, South directed to

Judicial Magistrate, Court No. 5, Karachi, copy of order is enclosed herewith, after that, on 14-05-14, I SIO. / Inspector having appeared before the Court of Area Magistate, Court No. 5, South, prayed through application in writing to fix the date and time for identification parade of accused Salman Abro to be got conducted through case complainant and eye witnesses in Ziauddin Hospital, Sheerin Jinnah Colony, Clifton, Karachi, uponwhich, the Area Magistrate has fixed the date i. e. 15-05-14 for proceeding of identification parade, copy of application is enclosed, after that, the case complainant and eye witnesses were bound down through notice U/s. 160 Cr. P. C. that the date i. e. 15-05-14 has been fixedfor identification parade of main accused in the said case named Salman Abro S/o Ghulam SarwarAbro who is under treatment in Ziauddin Hospital, Sheerin Jinnah Colony having directions them to appear on fixed date and time, copies of served notice are enclosed herewith, and main accused Salman Abro S/o Ghulam SarwarAbro was served information notice in hospital, copy of notice is enclosed herewith. On 15-05-14, letter was issued to the administration of Ziauddin Hospital, Sheerin Jinnah Colony, Clifton, Karachi and it was got received there, and the Area Magistrate, Court No. V, South, PS., Darakhshan came at Ziauddin Hospital, Sheerin Jinnah Colony, Clifton and on making proper arrangement of dummies in Seminar Hall, Second Floor, Ziauddin Hospital, pray was made in writing for proceeding of identification parade of accused Salman Abro S/o Ghulam SarwarAbro,

uponwhich, the Magistrate, Court No. V, South called one by one to case complainant Zeeshan Mustafa Lashari and eye witnesses namely: Mst. IrumNaz (mother of slain) and Mr. Rahimuddin S/o Muhammad Salahuddin and house servant Riyazat Ali alias Joji S/o KaluDilawar and got conducted the identification parade, case complainant and above said witnesses identified perfectly to the accused Salman Abro S/o Ghulam SarwarAbro, pray was made in writing to obtain the verified copies of proceeding of identification parade, obtained verified copies are enclosed herewith.After registration of the above case, I the SIO, tactfully interrogated to arrested accused persons namely: PC / YaseenJamali, PC / Muhammad Rashid S/o Muhammad Rafiq, PC / Imran Ali S/o Muhammad Boota, PC / Maqbool Ahmed S/o Niaz Muhammad in the above case. During interrogation, they confessed their guilt and disclosed that they can get pointed out the place of occurrence, therefore, on the confession and disclosure of said accused persons. I the SIO alongwith officials brought arrested accused persons reached at the place of occurrence by means of official mobile and they pointed-out the place of occurrence. Memo regarding pointation of the place of occurrence and statements of witnesses are enclosed with the case file. After that, record of vehicle no.CU-2900 maker VIGO black colored was obtained from Civic Centre. In the above case, mobile phones used by the arrested accused persons namely: PC / YaseenJamali S/o Khuda Bakhsh Jamli, PC / Muhammad Rashid S/o Muhammad Rafiq, PC / Imran Ali S/o

Maqbool Ahmed S/o Niaz Muhammad got Muhammad Boota, PC/ deposited in the office of Digital Branch for Analysis, copy of receiving letter and received report of mobile phone of the accused persons are enclosed with the case file. On 16-05-2014, the above named accused persons were produced in the competent court for obtaining remand, upon which, competent court granted police custody remand of above accused persons till 22.05.2014 and directed to produce again the said accused persons on 23.5.2014, the copy of remand is enclosed with the case file. During investigation, I, the SIO/Inspector alongwith Police Party of SCTC (Sakrand Training Centre) having gone to District ShaheedBenazirabad Sindh checked the register of arms, in which entry regarding above number recovered SMG used in the commission of crime in the above case is registered, which was taken into police possession in presence of witnesses and sealed-up. Memo regarding seizure and statements of witnesses as per memo are enclosed with the case file. During investigation arms register of SCTC was found, in which recovered weapon of murder/official SMG No.73658 having two loaded magazine as per memo from the possession of accused PC Magbool Ahmed Brohi S/o Niaz Muhammad at the time of his arrest has been issued in the name of PC/89 Ulfat posted at SCTC, while weapon of murder/official SMG No.3770103 having loaded four magazine as per memo prepared by ASI Abid Hussain, which was used under the possession of dead accused PC / Zaheer Ahmed Rind and the same has

been issued in the name of PC / Muhammad Rashid Gujjar S/o Muhammad Rafiq as per arms register of SCTC, while weapon of murder/official SMG No.73658 having two loaded magazine as per memo has recovered from the vehicle No.CU-2900 maker VIGO black color of main accused Salman Abro S/o Ghulam SarwarAbro, and as per record of Arms register of SCTC, same official SMG has been issued in the name of PC/35 YaseenJamali. I, the SIO/Inspector sent letter to the line officer of SCTC to appear PC/89 Ulfat to record his statement and to provide detail regarding issuance of arms to the Gunman of SSP Ghulam SarwarAbro, the copy whereof is enclosed with the case file. In response whereof, reply of Line Officer SCTC was received through TCS which are consisting on two pages, same are enclosed with the case file. During investigation, misconduct report of accused persons (Police Constables) was sent to the higher officers. I the SIO, having gone to Ziauddin Hospital interrogated main accused Salman Abro s/o Ghulam SarwarAbro in the above case after approval from the doctor and got received letter to obtain medical history, receiving letter is enclosed with the case file. On 21-05-2014, DrAnok Kumar Medical Superintendent of Ziauddin Hospital Sherin Jinnah Colony handed-over discharged card and samples of foreign bodies duly sealed, which were found at the time of operation of main accused Salman Abro s/o Ghulam SarwarAbro from his body to me the SIO/Inspector, discharged letter is enclosed with the case file. I the SIO brought accused Salman Abro at

above Police Station and interrogated him, during interrogation, accused Salman Abro disclosed that he is feeling pain at the side of operation, therefore above accused was again shifted to Ziauddin Hospital, where doctors again admitted him in Ziauddin Hospital. On 22.05.2014, case property (sample of foreign bodies of accused Salman Abro) duly sealed) which were handed-over by the Medical Superintendent Doctor Anok Kumar of Ziauddin Hospital got deposited in the office of FSL for examination and report, the copy of receiving letter and obtained report are enclosed with the case file. On 23.5.2014, above accused persons were produced in the competent court for obtaining remand, upon which, competent court granted police custody remand of said accused till 27-05-2014. Medical examination of main accused Salman Abro S/o Ghulam SarwarAbro got conducted from JPMC vide MI No.4412/12, as per discharged report of Ziauddin Hospital, age of accused Salman Abro is written as 18 years, while MLO of JPMC has also written 18 years age of accused Salman Abro s/o Ghulam Abro years in the medical report, remand report, medical report and CRO letter are enclosed with the case file. During investigation, father of accused Salman Abro named Ghulam SarwarAbro appeared at Police Station and produced photocopies of birth certificate of PNS Shifa and testimonial certificate of Cadet College Pitaro of accused Salman Abro, which are enclosed with the case file. Letter issued to the concerned departments regarding verification of birth certificate and testimonial certificate of accused, copy of receiving

letter alongwith TCS receipts and verification letter received from PNS Shifa are enclosed with the case file, while report is not received from Cadet College PitaroJamshoro till yet. During investigation, statements U/s 161 cr. P.C of witnesses namely: ShahnawazMohsin Shah Bukhari S/o Mohsin Shah Bukhari (late), Shaikh Muhammad Hamza S/o Muhammad Mansoor late, Jam Hyder Unnar S/o Jam Zulfiqar Ali Unnar, Jam Ali Korejo s/o Jam Noor Muhammad Korejo, Zeeshan Islam S/o Islam-ul-Haq, Hamzalqbal Ahmed, they disclosed in their statements that on 07-5-2014 in the night time, we came at Café Clifton Hotel in order to take meal and we took meal etc. on 08-5-2014 at about 1230 hours night time, Salman Abro came alone in his black color VIGO vehicle and he met with us and he having sat at the table and took meal, after at about one or 1-1/2 hours Salman Mustafa Lashari alongwith his three friends came in white color Toyota Corolla and he talked any matter with Salman Abro and they were beating to each other, then we all friends spared them. Detailed statements of witnesses are enclosed with the case file. On 26-5-2014, having taken the custody of main accused Salman Abro s/o Ghulam SarwarAbro after given written letter to the Medical Superintendent of Ziauddin Hospital, and having added in the investigation of above case interrogated him. During interrogation, above accused confessed his guilt and disclosed that he can get point-out the place of occurrence, therefore, on the confession and disclosure of above said accused. I the SIO alongwith staffers brought said accused left from

police station in order to point-out the place of occurrence by means of official mobile. The accused himself got stopped official mobile at street No.30 Khayaban-e-Shamsher, Phase-V, DHA, Karachi alighted from the vehicle left the police party by walking ahead made pointation of the place of occurrence/bungalow in presence of witnesses, memo regarding pointation of the place of occurrence and statements of witnesses are enclosed with the case file. On 27-5-2014, above named accused persons were produced in the competent Court for obtaining remand in the above case, upon which, Hon' ble Court granted judicial custody remand of said accused till 02-6-2014, therefore, said accused persons were handed-over to the jail authorities, jail warrant is enclosed with the case file. During investigation, it was found that above accused persons having entered into the aforesaid bungalow caused injured guard Ali Ghulam Bughti, committed murder of Suleman Mustafa Lashari with firearms weapon (SMG) inside the bungalow and offence has fully proven against said accused persons, therefore, Section 457 has been added in the above case. After completing the investigation, report U/s 168 Cr. P.C was sent to the higher officers for approval, upon which, SP Investigation has passed order No.SP/INV-I/South dated 11.6.14 approved report and directed to prepare Challan U/s 457 R/W Section 302/324/427/34 PPC 7 ATA against dead accused PC / Zaheer Ahmed Rind and his name be written from the blue ink in column No.2.

From the investigation conducted up-till now, the main accused Salman Abroalongwith his accomplices came at the bungalow of case complainant i.e. Bungalow No.30/I Street No.30 Khayaban-e-Shamsher, Phase-5, DHA Karachi by riding in his vehicle No.CU-2900 Maker VIGO black colored and main accused Salman Abro stopped his vehicle and he alighted from his vehicle, made firing at the main gate of bungalow from official SMG of PC / YaseenJamali, his co-accused by seeing the said firing alighted from the vehicle made firing at the main gate of case complainant on the instance of main accused Salman Abro. Accused persons having found open small gate of said bungalow entered into the said bungalow where injured security guard stopped them and on the instance of main accused Salman Abro, PC / Magbool Ahmed, PC /Zaheer Ahmed Rind holding official SMG in their hands made firing upon security guard Ali Ghulam Bughti with intention to kill him, resulting which, he caused injured. The main accused Salman Abro S/o Ghulam SarwarAbro while accosting slain Suleman Mustafa Lashari sitting in the lawn of bungalow for preparation of examination, due to quarrel/grudge occurred some days ago from the day of occurrence with them made firing upon him from official SMG holding in his hand and killed him. Case complainant and security quard Ali Ghulam Bughti retaliated in their self defence, in a result of which, main accused Salman Abro caused injured and his co accused PC / Zaheer Ahmed Rind (Gunman) died. The co-accused persons namely: PC /

Magbool Ahmed, driver / PC Muhammad Rashid Gujjar, PC / YaseenJamali, PC / Imran Ali having boarded their main accused Salman Abro in injured condition escaped away from the place of occurrence. The said incident was published at the different TV Channels and Print Media, from which fear and panic have spread in the area people and other people. The offence has fully proven against arrested accused persons and dead accused PC Zaheer Ahmed Rind in the above case, therefore, having prepared above charge sheet U/s 302/324/427/34, 457 PPC R/W 7 ATA dated today against arrested accused persons namely: (1). Mir Salman SarwarAbro s/o Ghulam SarwarAbro, (2). PC/147 Maqbool Ahmed Brohi S/o Niaz Muhammad, (3). PC/156 Imran Ali S/o Muhammad Boota, (4).PC/ 35 YaseenJamali S/o Khuda BakhshJamli, (5). PC / driver Muhammad Rashid S/o Muhammad Rafig, which is submitted in this Hon' ble Court, while name of dead accused PC / Zaheer Ahmed Rind was written from blue ink in column No.2 of the charge sheet. It is prayed that after proceeding legal redressal may be made.
