As regards the K-Electric, some reports have been made, however, during course of arguments, our attention is drawn towards the observations and objections raised by the NEPRA about the load-shedding and the performance of the K-Electric. The learned counsel and the representative of the K-Electric state that they would like to meet those objections in writing and also would like to place on record a proper plan with the time frame as to how and within what period the issue of load-shedding could be resolved in the area falling

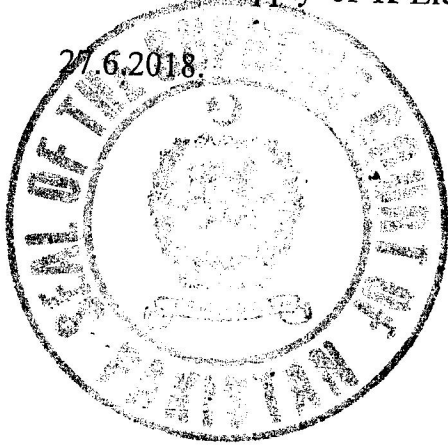
