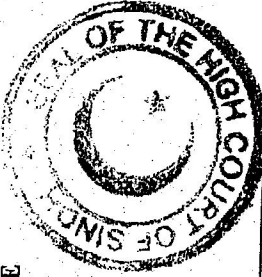

Sir,

It is submitted that, I, Sher Khan Awan Excise Inspector along with staff proceeded vide Entry No.449, of station diary after receiving secrete information proceeded to Butto stop, Mirpur Khas road for checking and started checking. During the course of checking, one bus arriving from Karachi for proceeding to Mirpurkhas, from where one woman was found in suspicious condition and a big plastic bag was lying in her lap, which was checked by LHC, Razia Mauhram and 10 Kg 350 grams of charras was recovered. The said woman disclosed her name as Mst. Aasia @ Nafisa wife of Abdul Hameed Baloch, who was arrested there. From the recovered charras 100 grams of charras was separated and sealed for examination and the remaining charras of 10 kilo 250 grams was sealed. Memo was prepared which wa signed by F/C Ghulam Rasool and LHC Razia Maharam. After returned to Office, case was registered.

It is submitted that the investigation of the case was conducted by my self, Inspector Sher Khan Awan, who interrogated the accused Mst. Aasia @ Nafeesa and she confessed her guilt. She further disclosed that her companion Saleem S/O Abdul Rehman Kashmiri Baloch, who was sitting on the same coach at rear seat and she along with him used to transport charras from Karachi to Mirpurkhas. The statement of witnesses were recorded. It was tried utmost to arrest accused Saleem Baloch, but could not be arrested. The case is hereby challaned /forwarded after 14 days and the absconding accused is hereby challaned U/S 512 Cr.P.C.
