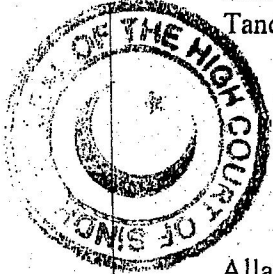

Her name was enquired, who disclosed her name as Aasia @ Nafeesa W/o Abdul Hameed Baloch, resident of Meera Naka, Iyari, Karachi,


thereafter, recovered property was weighed and its weight was found 10 kilo and 350 grams. One hundred 100 grams was separated from the packets in small shapes and was sealed for chemical examinations. The remaining case property of 10 kilo grams 250 grams was sealed at the spot and the accused was also arrested at the spot. Memo was prepared at the spot, read over to the witnesses and they signed it after accepting correct. Thereafter the accused and case property was brought at P.S and the case was registered U/S 9/C.
