

## **ORDER**

In compliance with this Court's order, the Additional Chief Secretary/Secretary Health, Sindh submitted a report today, a copy whereof has been given to Mr. Faisal Siddiqui, learned ASC for his perusal and comments. However, the Additional Chief Secretary concedes that the Drug Testing Laboratory has not been made functional till date even though there was a specific direction of this Court to do so within a period of two months. When questioned as to what steps have been taken in this regard in the last three and a half months and precisely how much more time is required to achieve the aforementioned objective, the Additional Chief Secretary states that a comprehensive detailed report along with the timetable for steps to be taken in the near future shall be submitted. Let the needful be done within a period of one week and the matter be listed for hearing after the summer vacations of 2018, subject to the availability of the Bench at Karachi.

- 2. The report of the Commission constituted *vide* order dated 20.06.2018 has been received. Let the Government of Sindh and the Health Department, Sindh file their comments within the same period.
- 3. After hearing the various parties, we are of the view that the Minister Health, Government of Sindh and the Additional Chief Secretary/Secretary Health should hold a meeting with the fathers of the minors, namely, Mr. Rafiq Ahmed (father of Qamar, minor), Mr. Muhammad Yousaf (father of Muhammad Zubair, minor), Mr. Khadim Hussain (father of Hasnain, minor) and Mr. Imran Ali (Hania Noor, minor), consider their grievances and submit a comprehensive report to the Registrar of this Court for our perusal in Chambers.
