Basically the petitioner has approached this Court for the implementation of Sindh HIV and AIDS Control Treatment and Protection Act, 2013. Under Section 3 of this Act it is responsibility of the Sindh Government to implement and enforce this Act with certain powers given under the same section, whereas under Section 4 it is further provided that the Government shall within fifteen days from the promulgation of the Act, by notification, establish a Commission for prevention, control, care, support and treatment of HIV and AIDS in the Province of Sindh. Learned counsel argued that despite promulgation of the Law in 2013 no Commission has been made so far to effectually implement the Act. The learned AAG is directed to submit the comments and he will also intimate this



Court as to when the Commission will be constituted. He will also submit the data with regard to HIV and AIDS patients in Sindh that can be collected by him from Health Department. Counsel for the Petitioner is directed to supply copy of the petition to the learned AAG during course of the day. Learned AAG will also call the Additional Health Secretary, Government of Sindh as well as responsible officer of the Commission on the next date. The respondent No.7/Director General Bureau of Statistics has submitted comments in compliance of the order dated 10.07.2019, copy has been supplied to the counsel for the petitioner. Dr. Minhaj Qidwai, CEO, Sindh Health Care Commission is present and he categorically stated that the entire data of the HIV patients is available with the Health Department and Health Care Commission has nothing to do with the data. Since we have already directed learned AAG to do the needful, therefore, presence of the Chief Executive Officer of Sindh Health Care Commission is not required till further orders. Adjourned to 27,08.2019 at 11:00 a.m.
