## ORDER

There have been some concerns expressed on behalf of the government of Sindh and the Federal Government that the operation for purposes of clearing encroachments in Karachi are not being enducted as per the mandate given by this Court. Besides, in the garb of such orders, houses and business premises of the people living and working over there since long are being demolished without giving them opportunity of hearing. When confronted with the above, Mr. Wasim Akhtar, Mayor Karachi categorically and unequivocally stated that not a single house has so far been demolished and only encroachments on footpaths, nalas, parks and amenity plots are being removed. Obviously, this is what the Court had desired through its various orders on the subject. Be that as it may, let all the three concerned i.e. the learned Attorney General for Pakistan, the learned Advocate General Sindh and the Mayor Karachi sit together and work out a plan as to how these encroachments can systematically be removed. They will submit a consensual plan before the Court tomorrow morning at 8:30 p.m. positively.

Crl.M.A.199-K/2018: Mr. Faisal Siddiqui, learned ASC has pointed out that notice for demolition has been issued to the National Museum situated on Bans Road which houses large number of articles which constitute a national heritage. The Mayor Karachi undertakes that only new constructions including shops around the said museum would be demolished and that the Museum shall not be demolished unless a suitable alternate site for such a Museum is found. None of the sides have raised any objection regarding removal of encroachments. The only concern of the Government of Sindh appears to be its ability to match

the speed of the anti encroachment drive with its rehabilitation plan. We however reiterate our earlier order that encroachment of footpaths, amenity plots, parks and nallas must immediately be removed. We observe that national museum should not be demolished unless some plan is prepared for its shifting at proper place.
